### ORDER:-

In the D.O. letter first read above, the Joint Secretary to Government of India, Ministry of Tribal Affairs has made tentative allocation of funds amounting to Rs.819.00 lakhs for the current financial year (2011-12) under the Grant-in-aid of Article 275(1) of the Constitution of India. He has also requested the Government to furnish project proposals for the year 2011-2012 within the allocated amount after identifying the thrust areas, including the provision both for existing EMR Schools and new EMRS proposed to be setup in the State as per the guidelines on EMRS revised in June 2010 and the activities should be separately categorized as 'Capital' and 'General'.

2. Accordingly, the project proposals submitted by the Director of Tribal Welfare in the letter second read above have been recommended and forwarded to Government of India by this State Government in D.O. letter third read above, for consideration.

- 3. In the letter fourth read above, the Director, Ministry of Tribal Affairs, Government of India has conveyed the release of a sum of Rs.260.70 lakhs (Rupees Two Crore Sixty Lakh and Seventy Thousand only) towards creation of Capital Assets and Rs.353.55 lakhs (Rupees Three Crore Fifty Three Lakh and Fifty Five Thousand only) towards Grant-in-Aid General, totally Rs.614.25 lakhs (Rs.260.70 lakhs + Rs.353.55 lakhs) against the allocation of Rs.819.00 lakhs of Grant-in-Aid to this Government under Article 275 (1) Constitution of India as payment of Central Assistance during the year 2011-2012 for carrying out the activities proposed in the D.O. letter third read above.
- 4. As the Government of India have released only a sum of Rs.614.25 lakhs, the Director of Tribal Welfare has been requested to select the projects out of the project proposals approved by the Government of India giving top priority to the felt need activities. Accordingly, the Director of Tribal Welfare in the letter fifth read above has furnished the projects for a sum of Rs.614.25 lakhs.
- 5. The Government after careful examination, accord sanction of Grant-in-Aid of Rs.6,14,25,000/- (Rupees Six Crore Fourteen Lakhs and Twenty Five Thousand only) under the Grant-in-Aid of Article 275(1) of the Constitution of India for year 2011-12 for the schemes mentioned in the Annexure to this Government order.
- 6. The expenditure sanctioned in para 5 above shall be debited to the following Head of Account :-

"2225 Welfare of Scheduled Castes, Scheduled Tribes and Other Backward Classes-02 Welfare of Scheduled Tribes – 796 Tribal Area Sub – Plan - Schemes in the Eleventh Five Year Plan – III. Centrally Sponsored – SA-Development of Particularly Vulnerable Tribes (Funds released by the GOI under Article 275(i) of the Constitution of India – 09 Grants-in-Aid – 03 – Grants for Specific Schemes. (DPC 2225 02 796 SA 0939).

- 7. The Director of Tribal Welfare is authorized to draw and disburse the amount of Rs.3,25,50,000/- lakhs (Rupees Three Crore Twenty Five Lakhs and Fifty Thousand only) towards recurring cost for two Ekalvya Model Residential Schools out of the total amount of Rs.614.25 lakhs sanctioned in para 5 above to the Tamil Nadu Tribal Welfare Residential and Educational Institutions Society. The Director of Tribal Welfare is instructed to incur the recurring expenses as per the available strength of the students of the schools and as per the revised norms fixed by the Ministry of Tribal Affairs.
- 8. The Director of Tribal Welfare is also authorized to draw and disburse the balance amount of Rs.2,88,75,000/- (Rupees Two Crore Eighty Eight Lakhs and Seventy Five Thousand only) to the District Collectors / implementing Agencies concerned of the schemes mentioned in the Annexure to this order.
- 9. The implementing authorities i.e. District Collectors / Implementing Agencies concerned shall ensure the following aspects while taking up / implementing the projects indicated in the annexure to this order:

- a) Construction component of the project, if any, is based on the schedule of rates of CPWD / PWD or any other scheduled of rates approved by the competent authority.
- b) Projects has the clearance of the State Government from the technical / financial /administrative angles.

The District Collectors / Implementing Agencies are requested to send the progress report every quarter with physical and financial progress in the prescribed format to Government in Adi Dravidar and Tribal Welfare (MEC) Department. The Utilization Certificates may be furnished within 12 months from the date of release of the amount to Government through the Director of Tribal Welfare who shall be the overall monitoring authority for the scheme.
