ORDER:-

This department is implementing the Housing scheme for the welfare of Scheduled Tribes from out of the funds sanctioned under Article 275(1) of the Constitution of India, the Central Sector Scheme for the development of Particularly Vulnerable Tribal Groups as well as the State Government. These houses were previously constructed by the District Rural Development Agencies concerned. As the District Rural Development Agencies concentrated only on their department's work, the work of construction of houses for Scheduled Tribes came to a standstill. Consequently, in the Government order first read above, orders have been issued for transferring the pending housing works hitherto implemented by the District Rural Development Agencies to TAHDCO.

2. The TAHDCO has also not implemented the scheme even though funds were transferred. However, requested the following rate for construction of a house on par with the PWD rate fixed during the year 2008-09:-

- (i) Rs.1,52,000/- in Coimbatore District
- (ii) Rs.1,05,000/- in Trichy District
- (iii) Rs.1,25,000/- in Krishnagiri District

As the rate fixed by the PWD is higher than the amount so transferred, TAHDCO has returned the amount to Trichy and Krishnagiri districts.

3. In view of the inability of the DRDAs and the TAHDCO, the Forest Department was requested to execute the works and the Principal Chief Conservator of Forests has agreed to execute this housing scheme at the rate of Rs.55,000/- per house in plains and Rs. 58,500/- per house in hilly or rocky areas. Accordingly, orders have been issued in G.O. second read above directing the concerned District Collectors and District Managers of TAHDCO to transfer the amount had with them in respect of the housing scheme to the District Forest Officers concerned.

4. Accordingly, required details have been received from the Director of Tribal Welfare to construct 1197 houses through Forest Department sanctioned at the rate of per house was Rs.34,000/-, Rs.36,500/-, Rs.55,000/- and Rs.58,500/- during the years 2003-04 to 2008-09). Consequently, orders have been issued in Government Letter No.3153/TD1(1)/09-9, Dated 1.12.2009, initially for construction of 933 houses through Forest Department i.e. 644 houses at the rate of Rs.58,500/- and 289 houses at the rate of Rs.55,000/- which have been sanctioned for the years 2008-09 and 2009-10.

5. Subsequently, the Director of Tribal Welfare has reported that still there are 264 houses sanctioned during the years 2003-04 to 2006-07 have to be constructed in Trichy, Krishnagiri, Coimbatore, Tiruvallur, Kancheepuram and Cuddalore districts. He has therefore requested the Government to issue orders for the construction of 162 houses instead of 264 houses at a total cost of Rs.93.09 lakhs each at Rs.55,000/- or Rs.58,500/- as the case may be and the remaining amount of Rs.2,30,500/- for the provision of basic amenities in the concerned districts.

6. The Government after careful examination of the proposal of the Director of Tribal Welfare, permit him to construct of 162 houses instead of 264 houses involving a total cost of Rs.93.09 lakhs at the rate of Rs.55,000/- or Rs.58,500/- each as the case may be and to utilize a sum of Rs.2,30,500/- for the provision of basic amenities to the above houses through Forest Department, as per the annexure to this order.

7. The Principal Chief Conservator of Forests shall ensure the proper implementation of the scheme. The Principal Chief Conservator of Forests and the concerned District Collectors are instructed to monitor the implementation of housing scheme and send the progress report to the Director of Tribal Welfare / Government.

8. The concerned the District Forest Officers are directed to execute the work within a short period and send a completion report / Utilization Certificates along with the list of beneficiaries to the Principal Chief Conservator of Forests and in turn he shall send the same to the Director of Tribal Welfare. The Director of Tribal Welfare shall be acting as the overall 'Monitoring Authority' to implement the scheme. He shall send the consolidated Utilization Certificates and beneficiaries list to Government shortly.

9. This order issues with the concurrence of Finance Department vide its U.O.No.1310/FS/P/2010, Dated 4.6.2010 and the Environment and Forest Department.

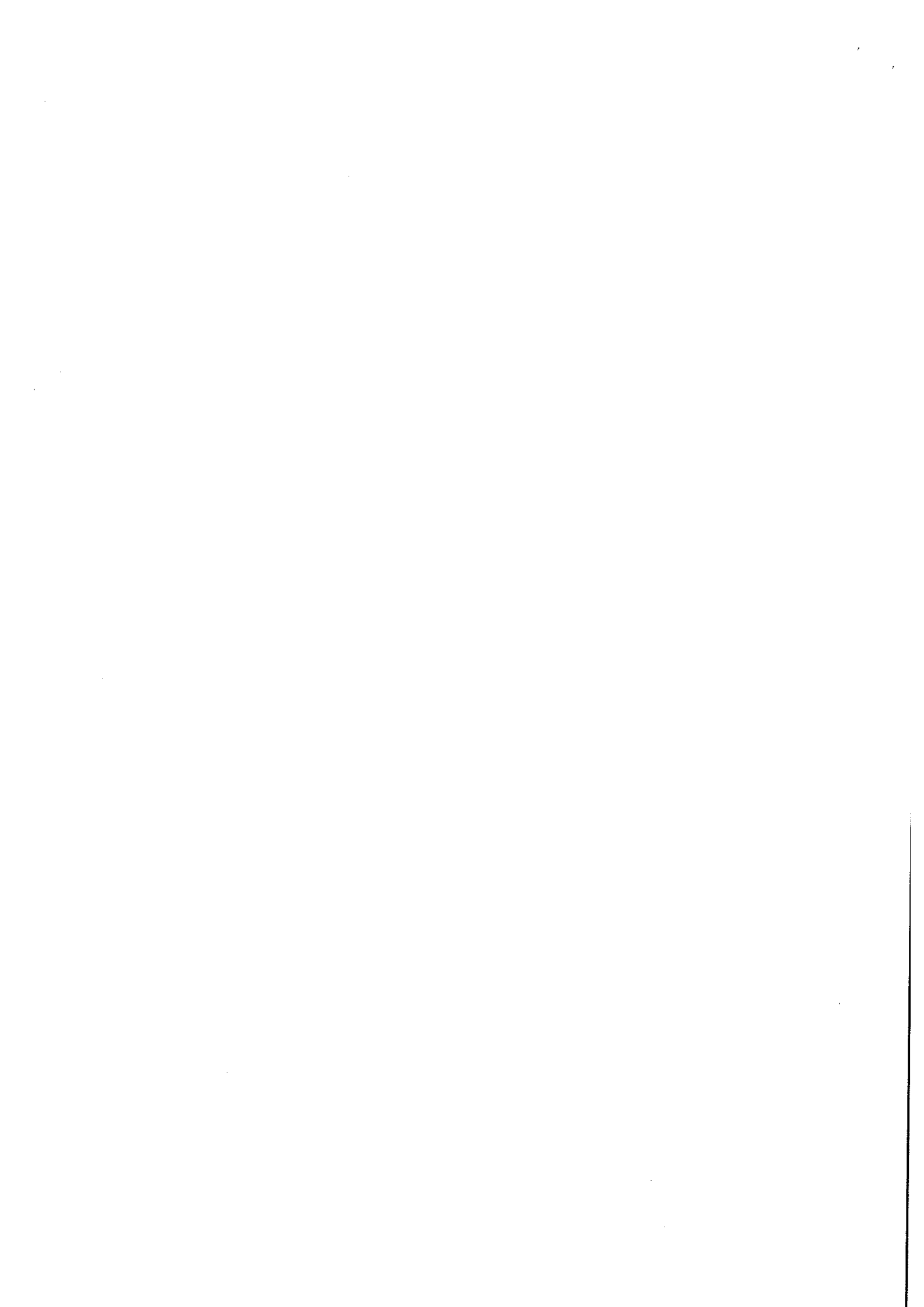


