### **ORDER:**

In the Government order first read above, Special Rules to the post of District Adi Dravidar and Tribal Welfare Officer under Section- 40 Tamil Nadu Adi Dravidar Welfare Service have been framed. In Rule 2 of Special Rules for the Tamil Nadu

Adi Dravidar Welfare Service for the post of District Adi Dravidar and Tribal Welfare Officer, the appointment shall be made by recruitment by transfer from the Deputy Collectors in Tamil Nadu Civil Service and Superintendents of Directorate of Adi Dravidar and Tribal Welfare in the ratio of 11:5.

2. In the Government order 2<sup>nd</sup> read above, amendment orders were issued to the Rule 3 of the Special Rules of the Tamil Nadu Adi Dravidar Welfare Service, for the appointment by transfer to the post of District Adi Dravidar and Tribal Welfare Officer.

3. In the Government order 3<sup>rd</sup> read above, temporary panels already drawn to the post of District Adi Dravidar and Tribal Welfare Officer from 1986-1987 to 2017-2018 have been regularized.

4. In the Government orders 4<sup>th</sup> & 5<sup>th</sup> read above, five Superintendents namely Tvl. (i) V. Joice (Retd. from service on superannuation on 31.05.2017), (ii) M. Kalaichelvi, (iii) D. Rajasri, (iv) B. Geetha and (v) Thiru. G. Elango have been temporarily promoted as District Adi Dravidar and Tribal Welfare Officer to meet out the exigencies of post and the services as per Section 47 (1) of Tamil Nadu Government Servants (Conditions of Services) Act, 2016 (Tamil Nadu Act No. 14 of 2016).

5. In the Government order 6<sup>th</sup> read above, the estimate of vacancy for the post of District Adi Dravidar and Tribal Welfare Officer by recruitment by transfer from the post of Superintendents of Adi Dravidar and Tribal Welfare Department for the year 2018-2019 has been fixed as 13 (Thirteen).

6. In the letter 7<sup>th</sup> read above, the Director of Adi Dravidar Welfare has sent proposal to the Government for approval of the names of eligible Superintendents in Adi Dravidar and Tribal Welfare Department for inclusion in the panel of District Adi Dravidar and Tribal Welfare Officer fit for appointment by recruitment by transfer to the post of District Adi Dravidar and Tribal Welfare Officer for the year 2018-2019.

7. The Government after examining the suitability and otherwise of the individuals, approve the names of the eligible 13 (Thirteen) Superintendents fit for inclusion in the panel for promotion as per the seniority to the post of District Adi Dravidar and Tribal Welfare Officer for the year 2018-2019 along with Tvl. (i) M. Kalaichelvi, (ii) D. Rajasri, (iii) B. Geetha and (iv) Thiru. G. Elango who have already been promoted as District Adi Dravidar and Tribal Welfare Officers to meet out the exigencies of post and the services as per Section 47 (1) of Tamil Nadu Government Servants (Conditions of Services) Act, 2016 (Tamil Nadu Act No.14 of 2016).

8. The post of District Adi Dravidar and Tribal Welfare Officer comes under the purview of the Tamil Nadu Public Service Commission. As per existing rules the said post is to be filled up after approval of the Departmental Promotion Committee. In the letter 9<sup>th</sup> read above, the Government has sent the proposal to the Tamil Nadu Public Service Commission for placing before the Departmental Promotion Committee. Accordingly, the Departmental Promotion Committee meeting was held on 11.07.2018 for selection of suitable candidates for inclusion in the regular panel for the post of District Adi Dravidar and Tribal Welfare Officer for the year 2018-2019 and the Tamil Nadu Public Service Commission has sent the recommendation of the Departmental Promotion Committee for finalizing the selection of candidates for the post of District Adi Dravidar and Tribal Welfare Officer in its letter 10<sup>th</sup> read above.

9. The Government after careful examination, has accepted the recommendations of the Departmental Promotion Committee and accordingly approve the names of following 13 Superintendents be included in the panel for appointment by recruitment by transfer to the post of District Adi Dravidar and Tribal Welfare Officer in Adi Dravidar and Tribal Welfare Department under Tamil Nadu Adi Dravidar Welfare Service for the year 2018-2019 in the order of seniority as indicated below:-

The Director, Adi Dravidar Welfare is requested to display the panel on the Notice Board and also to communicate to all persons concerned whose names are found in the list as well as to the persons senior to the junior most person, included in the list whose names have not been included in the panel by registered post with acknowledgement due as per section 7(1) of the Tamil Nadu Government Servants (Conditions of Services) Act, 2016 (Tamil Nadu Act No.14 of 2016).

The Director, Adi Dravidar Welfare is also requested to ensure that no one included in the panel has come to any adverse remarks on the date of issue of this order and that no charges under rule 17(b) of Tamil Nadu Civil Services (Discipline and Appeal) Rules are pending as on date in respect of any of them and these aspects are considered at the time of giving actual promotion also, if, in respect of anyone of them have charges under rule 17(b) of Tamil Nadu Civil Services (Discipline and Appeal) Rules or its equivalent are initiated or charge sheet have been filed in the criminal case after inclusion or before actual promotion, their names may be deferred till the completion of the proceedings and such cases may be dealt with as per Section 7(1) of Tamil Nadu Government Servants (Conditions of Services) Act, 2016 (Tamil Nadu Act No. 14 of 2016).

13. The Director, Adi Dravidar Welfare is requested to send the necessary proposal for postings to the individuals mentioned at para-9 above in consultation with the Director, Tribal Welfare to Government immediately.

14. Any person who wishes to make representation against non-inclusion of his/her name in the panel or regarding seniority shall do so, within a period of two months from the date of issue of this order.
