## ORDER:-

In the G.O. first read above, the scheme of Special Public Distribution System was extended for a period of one year from March 2018 to February 2019 with supply of one dal i.e. Tur Dal /Canadian Yellow Lentil and Palmolien Oil to meet 100% requirement of existing family cardholders.

In the letter third read above, the Commissioner of Civil Supplies and Consumer Protection has reported that the family cardholders are interested in getting the Tur Dal and Palmolein Oil being issued through fair price shops under Special Public Distribution System. She has also stated that implementation of this scheme enables controlling the open market price of these commodities. She has requested to extend the Scheme of Special Public Distribution System for further period of one year from March 2019 to February 2020.

3. The Government after careful examination, extend the scheme of Special Public Distribution System for a period of one year from March 2019 to February 2020 with supply of one dal i.e. Tur Dal / Canadian Yellow Lentil and Palmolein Oil to meet 100% requirement of the existing family cardholders.
