ORDER:

Government of India has approved the continuation of National Rural Health Mission (NRHM) for five years from 01.04.2012 to 31.03.2017 (i.e. coterminous with the 12th Five Year Plan) with expenditure to be shared between Centre and States in the ratio of 75:25 in place of 85:15 ratio in the 11th plan.

2. The Mission Director, State Health Society, in his letter read above, has stated that the state share of 25% towards National Rural Health Mission allocation has to be made available to the State Health Society as a matching grant based on the release received from the Government of India to carry out the approved programmes for the year 2013-14. An amount of Rs.358.7064 crore has been provided under B.E.2014-15 towards State Share contribution to the State Health Society to implement the schemes under National Rural Health Mission. The Mission Director, State Health Society has now requested the Government permission to draw an amount of Rs.7,11,76,700/- being the 25% State share under National Rural Health Mission, based on the Government of India releases to the tune of Rs.21,35,30,100 made for the year 2013-14.

3. The Government now accord permission to the Mission Director, State Health Society and Project Director, Reproductive and Child Health Project to draw an amount of Rs.7,11,76,700/- (Rupees Seven crore eleven lakh seventy six thousand and seven hundred only) towards the 25% State share under National Rural Health Mission to implement the programmes approved in the PIP for the year 2013-14.

4. The amount sanctioned in para 3 above shall be debited to the following head of account:

"2211-00 Family Welfare – 103 Maternity and Child Health – II State Plan JN State Share towards National Rural Health Mission Schemes – 09 – Grants in aid -03 Grants for Specific Schemes. (D.P.Code 2211-00-103-JN-0937)

5. The Mission Director, State Health Society and Project Director, Reproductive and Child Health Project, Chennai -6 is directed to incur the expenditure from the funds provided in B.E.2014-15 under the said head of account.
