From the Member Secretary, State Mental Health Authority, Letter No.98/SMHA/2014-1, dated 11.04.2014.

ORDER:-

During the second annual meeting, 2013 of State Mental Health Authority, Tamil Nadu, Conducted under the Chairmanship of the Secretary to Government, Health and Family Welfare Department, on 05.03.2014, among other things the issue of apportioning of licence fee collected for grant of licence to the Private Psychiatric Nursing Homes / Hospitals was discussed.

2. As per rules 22 and 25 of State Mental Health Rules, 2013, all the psychiatric hospitals / nursing homes have to remit licence fee for grant or renewal of licence to enable them to run the hospital / nursing home, as the case may be, for a period of five years. The psychiatric hospitals / nursing homes include Deaddiction centres, long standing rehabilitation homes etc. The following are the fee structure as per the rules:-

Sl.No	Category	Fees
1.	Less than 50 beds	Rs.10,000
2.	Less than 100 beds	Rs.15,000
3.	More than 100 beds	Rs.20,000

3. The Director, Institute of Mental Health who is the licensing authority, on receipt of the application for either grant of license or renewal of license directs the Psychiatrist attached to the nearest Government Medical Institution to inspect the Private Hospital and to submit report. The inspecting officer has to make his own arrangement to visit the private hospital / de-addiction centre which are at times, far away from the medical college. He/she has to spend on transportation by hiring a vehicle etc.. During the meeting it was decided that a sum of Rs.2000/- be paid to the inspecting officer out of the license fee collected.

4. The Secretary, State Mental Health Authority in the letter read above has requested the Government to accord permission to the Director, Institute of Mental Health who is the licensing authority to sanction Rs.2000/- (Rupees two thousand only) to the inspecting officer from out of the licence fee collected and maintained by him.

5. The Government after careful examination, accord permission to the Director, Institute of Mental Health, to sanction a sum of Rs.2000/- (Rupees two thousand only) to the inspecting officer out of the license fee collected and maintained by him.

6. This order issues with the concurrence of Finance Department vide its U.O. No.28461/H-II/14, dated 11.06.2014.


