ORDER:

In the Government Orders first and second read above, the Government have sanctioned a sum of Rs.10.00 crore for purchase of new furniture by replacing the old broken furniture of various Medical College Hospitals as per the announcement made by the Hon'ble Chief Minister under rule 110 of Tamil Nadu Legislative Assembly.

In his letter third read above, the Director of Medical Education has stated that in the above said Government Orders, a sum of Rs.1,00,00,000/- has been allotted to Government Medical College Hospital, Chengalpattu to purchase new furniture by replacing the old ones. In this connection, he has further stated that the Dean, Government Medical College, Chengalpattu has stated that at present, there is an urgent need of furniture to Medical College in view of the newly built Lecturer hall and Examination hall, since no furniture has been sanctioned to these newly constructed buildings. The Director of Medical Education has therefore requested the Government to issue necessary permission to utilize the amount of Rs.1,00,00,000/- sanctioned for replacing the old furniture to the Government Medical College Hospital, Chengalpattu to purchase new furniture to the newly built Lecture Hall and Examination Hall at Government Medical College, Chengalpattu.

3. The Government, after careful examination, have decided to accept the request of the Director of Medical Education. Accordingly, the Government permit the Director of Medical Education to utilize the amount of Rs.1,00,00,000/- (Rupees one crore only) already sanctioned to Government Medical College Hospital, Chengalpattu, to purchase new furniture by replacing the old broken furniture in Government Orders first and second read above, towards purchase of new furniture to the newly built Lecturer Hall and Examination Hall at the Government Medical College, Chengalpattu.
