ORDER :

In G.O.(Ms) No.465 to 470, Health and Family Welfare (MCA2) Department, Dated:15.10.2019; G.O.(Ms) No.536 to 538, Health and Family Welfare (MCA2) Department, Dated:29.11.2019; G.O.(Ms) No.47 to 48, Health and Family Welfare (MCA2) Department, Dated:10.02.2020, orders were issued for the establishment of 11 new Government colleges in 11 Districts, with an annual intake of 150 MBBS seats each, from the academic year 2021-2022.

2. In the circumstances stated by the Director of Medical Education in his letter read above, the Government permit the Director of Medical Education to incur an expenditure of Rs.92,15,800/- (Ninety two lakhs fifteen thousand and eight hundred only) at the rate of Rs.4,13,000/- per college for the following eleven Government Medical Colleges towards Application fees and Rs.4,24,800/- per college, for eleven Government Medical Colleges, towards Affiliation fees, from the Personal Deposit account of the Director of Medical Education, maintained by the Secretary, Selection Committee, for payment to the Medical Council of India, New Delhi and The Tamil Nadu Dr.MGR. Medical University, Chennai-32 from the Personal Deposit Account of the Director of Medical Education being maintained by the Secretary, Selection Committee:-

2. Viridhunagar.
3. The Nilgiris.
4. Dindigul
5. Tiruppur
6. Namakkal.
7. Nagapattinam.
8. Krishnagiri.
9. Thiruvallur.
10. Kallakurichi.
11. Ariyalur.

2. The Director of Medical Education is directed initially to incur the above expenditure from the Personal Deposit account of the Director of Medical Education being maintained by the Additional Director of Medical Education / Secretary, Selection Committee and reimburse it after obtaining Budget allotment, without fail.

3. The Director of Medical Education is directed to instruct the Deans of the Medical Colleges concerned to include the expenditure in the Revised Estimate / Final Modified Appropriation, 2020-2021 so as to reimburse the spent amount into the Personal Deposit account of Director of Medical Education.

4. The Director of Medical Education is directed to take necessary action accordingly.
