ORDER:

The Managing Trustee, Dharan Educational Charitable Trust, Salem has applied for permission to start Auxiliary Nurse Midwife Training Course in the name of Dharan School of Nursing with an annual intake of 60 students per batch / per year.

2. In the letter fourth read above, the Director of Public Health and Preventive Medicine has stated that the Managing Trustee, Dharan Educational Charitable Trust, Salem has applied for permission to start Auxiliary Nurse Midwife Training Course in the name of Dharan School of Nursing with an annual intake of 60 students per batch / per year and the Institution has submitted the application duly filled in the prescribed format and the Joint Director of Public Health and Preventive Medicine (Training) has inspected the above Institution on 15.5.2018 and the guidelines for the course have been followed and necessary supporting documents have also been furnished by the Institution.

3. The Director of Public Health and Preventive Medicine has also recommended and requested to accord permission to the Managing Trustee, Dharan Educational Charitable Trust, Salem to start Auxiliary Nurse Midwife Training Course

in the name of Dharan School of Nursing with an annual intake of 60 students per batch / per year, subject to the following conditions:-

- i. The Institution should obtain approval from the Indian Nursing Council, New Delhi and Registrar, Tamil Nadu Nurse and Midwives Council, Chennai before starting the course.
- ii. The examination can be conducted for the trainees who are undergoing the Auxiliary Nurse Midwife course in the above said Private Nursing School by the Director of Public Health and Preventive Medicine being the Chairman of Board of Examination.
- iii. To conduct exams for Auxiliary Nurse Midwife course subject to the following conditions:-
 - a) The internship for these trainees should be conducted in an Upgraded Government Primary Health Centres / Community Health Centres for a period of at least three months.
 - b) The trainees should undergo field practice in the identified Government Primary Health Centres only after paying the prescribed fees.
 - c) The Private Nursing Schools should construct building in the Affiliated Community Health Centres for accommodating the trainees.
 - d) The Institution and the candidates should pay the examination fees at the rate of Rs. 1000/- per paper per semester and other fees prescribed by the Government from time to time.

4. The institution has submitted the following particulars as stipulated in the G.Os 1st to 3rd read above:

- i. The undertaking is given in Rs.50/- Judicial stamp papers instead of Rs.5/- Judicial Stamp paper, as per the stipulations in guidelines.
- ii. An endowment fund for Rs.5/- lakhs (Rupees Five lakhs only) in the joint name of the Trust/Private Management and pledged in favour of the Director of Public Health and Preventive Medicine (in his official capacity)
- iii. Building Plan showing of class rooms, laboratories and library duly approved by the Panchayat President, Nilavarapatti Village, Salem.
- iv. Building Plan showing of hostel and mess facilities duly approved by the Special Officer / Block Development Officer (Village Panchayat), Nilavarapatti.
- v. The Experience and Qualification Certificates of Principal and Tutors as per Indian Nursing Council norms.

5. The Government, have examined the proposal of the Director of Public Health and Preventive Medicine and undertaking given by the Managing Trustee, Dharan Educational Charitable Trust, Salem. The above institution has running fullfledged Hospital. Therefore, the Government have decided to accept the recommendation of the Director of Public Health and Preventive Medicine and hereby direct that the Managing Trustee, Dharan Educational Charitable Trust, Salem be permitted to start Auxiliary Nurse Midwife Course in the name of Dharan School of Nursing with an annual intake of 60 students per batch from the academic year 2018-19, subject to the conditions prescribed in G.O. first to third read above

as a special case and the Institution should submit the following documents before admitting the students for the above said course:

- a) The lease deed registered in Sub Registrar Office for the proposed building;
- b) The Building Plan showing of class rooms, laboratories, library, hostel and mess facilities duly approved by the Director of Town and Country Planning; and
- c) The Building Completion Certificate issued by the Competent authority.

6. The Director of Public Health and Preventive Medicine should ensure that the conditions prescribed at para 5 above are fulfilled by Dharan Educational Charitable Trust, Salem before admitting the students in the course.


7. This should not be quoted as a precedent for claiming such same case in future.
