ORDER:

1. In Government Order first read above, orders have been issued towards revision of guidelines and syllabus for the training to be imparted for Multipurpose Health Worker (Male) / Health Inspector / Sanitary Inspector course offered by the Private Institution / Trust / Universities / Deemed Universities.

2. In the letter second read above, the Director of Public Health and Preventive Medicine has stated that the Managing Trustee, Dharan Educational Charitable Trust, Salem has applied for permission to start two years Health Inspector course in the name of Dharan School of Paramedical Sciences in the prescribed format. Further, he has stated that the application has been scrutinized by him and found that the said Institution has followed the guidelines to start the Health Inspector Course. The Joint Director of Public Health and Preventive Medicine (Training) has inspected the above institution on 15.5.2018. The Director has, therefore, requested to accord permission to Dharan Educational Charitable Trust, Salem who has applied to start two years Health Inspector Course in the name of Dharan School of Paramedical Sciences with an annual intake of 40 students per batch / per year and submitted that the said Institution has followed the guidelines to start the Health Inspector Course.

3. The Director of Public Health and Preventive Medicine has recommended the request of the Managing Trustee, Dharan Educational Charitable Trust, Salem to

start Health Inspector Course in the name of Dharan School of Paramedical Sciences with an annual intake of 40 students per batch / per year, subject to the following conditions:

- a) The Training Institute should be affiliated to a Community Health Centre and an Urban Local Body near to the institution in order to provide field practice and required orders shall be obtained from the competent local authority;
- b) The Teaching Facilities, Teaching and Non-Teaching Staff, Office, Classrooms, Laboratory, Sanitary Engineering Workshop, Library, Health Education Section and Hostel facilities should be as per the prescribed guidelines;
- c) The Director of Public Health and Preventive Medicine will be Chairman of the Board of Examination to conduct the examinations of Health Inspector course, subject to the following conditions:-
 - i. The candidates will be informed in writing that successful candidates will not claim as a matter of right, eligible for Tamil Nadu Government Service;
 - ii. The fees prescribed by the Government shall be remitted into Government Treasury for the allotted Community Health Centre / Urban Local Body for field practice training by the Institution; and
 - iii. The Institute and candidates should pay the prescribed examination fees at the rate decided time to time by the Board of Examination;
 - iv. The selection rules, curriculum and regulations given in the annexure should be followed without fail and deviation.

4. The Government have examined the proposal of the Director of Public Health and Preventive Medicine and undertaking given by the Managing Trustee, Dharan Educational Charitable Trust, Salem. The above institution has running fullfledged Hospital. Therefore, the Government have decided to accept the recommendation of the Director of Public Health and Preventive Medicine and accordingly permit the Managing Trustee, Dharan Educational Charitable Trust, Salem to start Health Inspector Course in the name of Dharan School of Paramedical Sciences at 3/136 Nilavarapatty, Salem – 636 201 with an annual intake of 40 students per batch from the academic year 2018-19, as a special case, subject to fulfillment of the conditions prescribed at para 3 above and the Institution should submit the following documents before admitting the students for the above said course:

- a) The lease deed registered in Sub Registrar Office for the proposed building;
- b) The Building Plan showing of class rooms, laboratories, library, hostel and mess facilities duly approved by the Director of Town and Country Planning; and
- c) The Building Completion Certificate issued by the Competent authority.

5. The Director of Public Health and Preventive Medicine should ensure that the conditions prescribed at para 4 above are fulfilled by Dharan Educational Charitable Trust, Salem before admitting the students in the course.

6. This should not be quoted as a precedent for claiming such same case in future.
