ORDER:-

In the Government order first read above, a sum of Rs.36,99,10,500/- was released as grants for the 1st quarter of the Financial Year 2019-2020 out of the Budget Estimate provisions of Rs.149,81,74,000/- to Tamil Nadu Manual Workers Social Security and Welfare Board and fourteen (14) other Welfare Boards under various heads for providing Financial Assistance and Administrative expenses.

2. In the letter second read above, the Commissioner of Labour has requested to release an amount of Rs.77,28,29,000/- under General Category for the 2nd quarter allotted in the Budget Estimate for the Financial Year 2019-2020, to the Tamil Nadu Manual Workers Social Security and Welfare Board and fourteen (14) other Welfare Boards by relaxing the quarterly control of appropriation.

3. The Government, after careful consideration, release a sum of Rs.77,28,29,000/- (Rupees seventy seven crores twenty eight lakhs and twenty nine thousand only) as grants for the financial year 2019-2020 under General Category out of the Budget Estimate to Tamil Nadu Manual Workers Social Security and Welfare Board and fourteen (14) other Welfare Boards for providing financial assistance and administrative expenses by relaxing quarterly control of appropriation system for which orders issued in G.O.(Ms).No.121, Finance (BG-I) Department, dated 31.03.2019.
