



## ABSTRACT

Minimum Wages Act, 1948 (Central Act XI of 1948) – Revision of minimum rates of wages for employment under any local authority – Orders - Issued.

### ORDER:

In the Government Order first read above, the minimum rates of wages for the employment under any local authority were revised under the provisions of the Minimum Wages Act, 1948. In the Government Order second read above, a Committee was appointed under the Chairmanship of the Deputy Commissioner of Labour, Madurai for revision of Minimum rates of wages for the employment under any local authority. The said Committee conducted various meetings with the employers and employees and submitted a report to the Commissioner of Labour.

2) The Commissioner of Labour in his letter third read above, has sent the report of the said Committee along with his recommendations to the Government for the revision of minimum rates of wages for the employment under any local authority.

3) The Government have carefully examined the report of the said Committee and the recommendations of the Commissioner of Labour. The Government accepts the recommendations of the Commissioner of Labour and have now decided to revise the minimum rates of wages for the employment under any Local authority.

4) The appended Notification will accordingly, be published in the Tamil Nadu Government Gazette both in English and Tamil. The Works Manager, Government Central Press, Chennai-600 079 is requested to send five copies of Gazette to the Government and the Commissioner of Labour for reference and record. The Secretary to Government, Tamil Development and Information Department, Secretariat, Chennai-600 009 is requested to send the Tamil Translation of the Notification to the Works Manager, Government Central Press, Chennai-600 079.
