ORDER:

As per Article 320(1) of the Constitution of India, the major function of the Tamil Nadu Public Service Commission is to recruit personnel for various posts in this State by direct recruitment.

2. As per rule 4 of the Rules of Procedures for the Tamil Nadu Public Service Commission, the Commission shall announce examination Notifications for direct recruitment through advertisement in any one or two of the dailies in Tamil and any one of the dailies in English with wide circulation and also through Tamil Nadu Public Service Commission Bulletin, besides other mass media depending on the nature and number of posts as the Commission may decide on each occasion.

3. The Tamil Nadu Public Service Commission has introduced Online Application System for all the Examinations conducted by the Commission, since 2012. The online system provides all services including notification of examinations. Further, a "One-time Registration Facility" for the candidates, in which, one can fill his bio-data particulars and also upload his signature and photo by paying a nominal amount, which will serve as a permanent data base of the candidates.

4. As the Tamil Nadu Public Service Commission has introduced online process of examination system and most of the aspirants of the Tamil Nadu Public Service Commission have a clear feedback relating to the recruitment of the Commission through online, Government hereby directs the Tamil Nadu Public Service Commission to issue Notifications for the examinations conducted by it elaborately in its official website and also to issue a Gist advertisement in Newspapers

regarding the Notification hosted in its website. The following Gist advertisement is a model for reference:-



