2) The Standing Finance Committee has approved the proposal for Implementation of Capacity building and skill development in Advanced Statistical Packages as recommended by the State Planning Commission at a cost of Rs. 73.52 lakhs under Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2016-2017, 2017-2018 and 2018-2019.

3. In the reference 3<sup>rd</sup> cited, the Principal Secretary/ Commissioner of Economics and Statistics has requested the Government to incur the expenditure Rs.9.23 lakh per annum for 2017-18 and 2018-19, towards capacity building and skill development in Advanced Statistical Packages to the staff of Department of Economics and Statistics.

4. The Government accordingly sanction a sum of Rs.9.23 lakhs (Rupees Nine lakhs Twenty three thousand only) for Capacity building and skill development in Advanced Statistical Packages under Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2017-2018.

5) The expenditure sanctioned in Para-4 above shall be debited under following the Head of Account:
