ORDER

The State Planning Commission has recommended the proposal of Up-gradation of the E-evaluation System in Evaluation and Applied Research Department, at a total cost of Rs.8.50 lakhs under Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2018-2019.

- 2. The Director (FAC), Evaluation and Applied Research Department in the reference second read above has proposed to sanction a sum of Rs.8,50,000/- for Upgradation of the E-evaluation System under TANII for the year 2018-2019 (First Round).
- 3. The Government accordingly sanction a sum of Rs.8,50,000/-(Rupees Eight Lakhs Fifty thousand only) for Up-gradation of the E-evaluation System under TANII for the year 2018-2019 (First Round).

4. The expenditure sanctioned in Para 4 above shall be debited under following head of account:
