dates of such publication direct to the Government. So as to enable the Government to approve Declaration under section 6 within 15 days from the last of the date of publication of 4(1) Notification as per the time schedule prescribed in the Pert Chart vide G.O.Ms.No.1895, Revenue, Dated 27.8.90.
