ORDER:

The Chief Engineer, Water Resources Department, Plan Formulation in his letter read above has stated that Vanji Odai is a tributary of Marudhanathi river. There is an old anicut across the Vanji Odai and was feeding Kannimar Samudram tank through a supply channel upto the year 2005. During the flood in the years 2005 and 2007, the anicut was completely damaged and also the water flow from the anicut to the Kannimarsamudram tank through the supply channel of length 1073 Metre is affected by the deposition of silt. He has also stated that, it is proposed to construct a body wall for a length of 20 Metre and height of 2.6 Metre above the bed level, bund formation, Abutment, desilting the supply channel. By implementing this scheme, the water level of the nearby wells will be increased and an extent of 76.60 acres will be stabilised anticipating with additional food production of 68.82 Metric Tonne. No land acquisition is involved in this scheme and the Benefit Cost Ratio for this scheme works out to 1.2 : 1. The cost of this scheme for the schedule of rates 2010-2011 works out to Rs.22.00 lakhs. The work will be executed by the Chief Engineer, Water Resources Department, Madurai Region. Hence no additional staff will be required for executing the scheme.

2. The above scheme is approved by the Standing Finance Committee under Part II Schemes for the year 2010-2011. Accordingly, the

Government accord administrative sanction for the construction of Mallayagoundanpatti anicut across Vanjinadhi in Mallanampatti village of Nilakottai Taluk of Dindigul District at a cost of Rs.22.00 lakhs (Rupees Twenty two lakhs only). Petty Supervision charges and unforeseen items should not exceed 2.5% of total cost of works.

3. The expenditure sanctioned in paragraph 2 above, shall be debited to the following head of account:-

“4702 – Capital Outlay on Minor Irrigation – 101. Surface Water – Schemes in the Eleventh Five Year Plan - II. State Plan – JA. Special Minor Irrigation Programme – 16. Major Works” (DP code 4702 – 00 –101 – JA 1607).

4. The Chief Engineer, Water Resources Department, Madurai Region is requested to take up the work immediately and complete it within the cost and time limit. He is also requested to send the progress of the work to the Government, every month, periodically.
