ORDER:

In the letter first read above, the Director of Rural Development and Panchayat Raj has sent a proposal under NABARD-RIDF XXII for Construction of 51 bridges at an estimated cost of Rs. 60.9530 crore and in the letter 2nd read above Finance Department has forwarded the said proposal to NABARD for sanction of loan under NABARD-RIDF XXII.

2) In the letter 3rd read above, the Deputy General Manager, NABARD, has informed that the RIDF Project Sanctioning Committee (PSC) of NABARD among other things has accorded sanction for construction / reconstruction of 51 Nos. of bridges in 7 Districts of Tamil Nadu at the total cost of Rs. 60.9530 crore under NABARD-RIDF XXII 2016-17.

3) Consequent to the sanction accorded by the NABARD in the letter 3rd read above, the Government after careful examination, accord administrative sanction for construction / reconstruction of 51 Nos. of Rural bridges in 7 districts of Tamil Nadu at an estimated cost of Rs.60.9530 crore (Rupees Sixty crore ninety five lakh and thirty thousand only) with loan assistance from the NABARD under Rural Infrastructure Development Fund-XXII (RIDF-XXII), as indicated in the Annexure to this order. In respect of construction / reconstruction of 51 Nos. of bridges, out of the total Project cost of Rs.60.9530 crore, the NABARD'S loan component would be 80% of the total value and the State Government's share would be 20% of the total value. Orders pertaining to Financial Sanction and Release of funds for taking up the above works under NABARD – RIDF XXII will be issued separately.

4) The Director of Rural Development and Panchayat Raj is requested to closely monitor the works and to ensure the quality of works is maintained as per the specifications and norms already in force. In this regard, detailed instructions should be given to the District Collectors by the Director of Rural Development and Panchayat Raj. The Director of Rural Development and Panchayat Raj is also requested to ensure that any of the above sanctioned works are not included in any of the other Schemes of Rural Development and Panchayat Raj Department or any other Departments before finalizing tender.

5) This orders issues with the concurrence of Finance Department vide its U.O. No.51912/RD/2016, dated 23.9.2016.
