In the Government Order 1st cited, orders have been issued towards Hiring of 329 vehicles to the tune of ₹ 3,53,67,500 for the year 2016-2017 from October 2016 to March 2017.

2. In the letter 2nd cited you have sent proposal to permit the District Project Officers and Child Development Projects Officers to continue the utilisation of the hiring vehicles expecting the Government orders after getting allotment in BE based on the approval of Annual Programme Implementation Plan of Government of India and also to permit them to adjust/settle the sanctioned funds to the concerned after obtaining the Government orders.

In the letter 3rd cited, Government of India have accepted the Annual Programme Implementation Plan inclusive of hiring of 339 vehicles for the year 2017-2018 and conveyed administrative approval for a sum of ₹ 43202.90 lakh inclusive of ₹ 728.85 lakh towards Hiring of 339 Vehicles for the year 2017-2018 in the sharing pattern of 60:40.

4. After careful examination, the Director, Integrated Child Development Services Scheme is authorised to permit the District Project Officers and Child Development Projects Officers to continue the utilisation of the 339 hired vehicles expecting the Government orders after getting allotment in BE based on Annual Programme Implementation Plan of Government of India and also to permit them to adjust/settle the sanctioned funds to the concerned after obtaining the Government orders.
