ORDER:-

Every year Government of India releases Special Central Assistance for the Economic Development of Adi Dravidars towards the implementation of Scheduled Castes Sub Plan (SCSP) in the State. The assistance received is transferred to the Personal Deposit Account of the Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO), for implementing Economic Development Schemes for Scheduled Castes by the TAHDCO and also through various other departments.

- 2. The Government of India in the letter second read above, have released an amount of Rs.39,15,00,000/- (Rupees Thirty Nine Crores and Fifteen lakhs only) being the first installment of Special Central Assistance to Scheduled Castes Sub Plan for the year 2012-2013. Accordingly orders were issued in the Government order third read above, sanctioning the amount to Managing Director, TAHDCO and Commissioner, Adi Dravidar Welfare for implementing various welfare schemes.
- 3. In the G.O first read above, it has been ordered that 10% of the Special Central Assistance Fund received from the Government of India, as Special Central Assistance to Scheduled Castes Sub Plan shall be released directly to the account of Commissioner of Adi Dravidar Welfare for providing infrastructure facilities to Scheduled Castes habitations and Adi Dravidar Schools/Hostels, and the balance 90% shall be

released to the Personal Deposit Account of TAHDCO through the Commissioner of Adi Dravidar Welfare for implementing Economic Development schemes for Scheduled Castes through various other departments.

- 4. The Government of India in the letter forth read above, have sanctioned to the Government of Tamil Nadu, a sum of Rs.83,33,00,000/- (Rupees Eighty Three crore and thirty three lakhs only) as second installment of Special Central Assistance to Scheduled Castes Sub Plan for the year 2012-2013. The Government of India has stated that the Special Central Assistance is an additive to the Scheduled Castes Sub Plan of the States/Union Territories and it should be used only for specific sector-wise, area-wise schemes aimed at income generating development programmes directly relevant to the economic upliftment of Scheduled Castes population in the areas. The Government of India has further stated that, any unspent balance amount of previous years cannot be carried forward for expenditure during the next financial year but should be adjusted against the amount of Special Central Assistance due to State Government administration for the current year at the time of release of final installment of the current year. The Government of India have also requested that the State Government should furnish quarterly progress report on the utilization of Special Central Assistance to the Government of India, Ministry of Social Justice and Empowerment, New Delhi within 15 days after the end of each quarter, in the prescribed proforma already available with the State Government.
- 5. Under Special Central Assistance to Scheduled Castes Sub Plan one sanction called M.E.C. (Monitoring and Evaluation Cell) is continuously functioning in Adi Dravidar and Tribal Welfare Department in the Secretariat for monitoring and watching the progress in implementation of various schemes, from the year 1981. The staff cost thereof for the current year 2012-2013 amounting to incurred under the Head of Account "2251-00-090-AP-01 Salaries" has to be adjusted with the Special Central Assistance fund received from the Government of India.
- 6. The Government after careful consideration accord sanction for a sum of Rs.83,33,00,000/- (Rupees Eighty Three crore and thirty three lakhs only) as second installment of Special Central Assistance to Special Component Plan for the year 2012-2013. The expenditure shall be debited to the following Head of Account:-
 - "2225 Welfare of Scheduled Castes, Scheduled Tribes and Other Backward Classes 01 Welfare of Scheduled Castes 793. Special Central Assistance for Scheduled Castes Component Plan Schemes in the Twelfth Five Year Plan III Centrally Sponsored SB Welfare Schemes for Scheduled Castes under Special Component Plan 09. Grants in aid 09 Others (D.P. 2225 01 793 SB 0998)"
- 7. The Government also permits to release a sum of Rs.8,33,30,000/-(Rupees Eight crore and thirty three lakhs and thirty thousand only) being the 10% of total amounts of Rs.83,33,00,000/- (Rupees Eighty Three crore, thirty three lakhs only) to be released to the Commissioner of Adi Dravidar Welfare, Chennai -5. Out of the balance, 90% amount of Rs.74,99,70,000/- (Rupees Seventy four crore, ninety nine lakhs and seventy thousand only) an amount of Rs.13,26,496/- (Rupees thirteen lakhs twenty six thousand four hundred and ninety six only) towards the Staff Expenditure of

Monitoring and Evaluation (MEC) Cell shall be adjusted and the balance amount of Rs.74,86,43,504/- (Rupees Seventy four crore, eighty six lakhs fourty three thousand five hundred and four only) to be released to TAHDCO for implementation of Economic Development Schemes for Scheduled Castes for the year 2012-13. Out of Rs.74,86,43,504/- (Rupees Seventy four crore eighty six lakhs fourty three thousand five hundred and four only) an amount of Rs.6,91,12,501 (Rupees six crore ninety one lakhs twelve thousand five hundred and one only) out of total amount of Rs.13,8225 crore is released to the Director of Handlooms & Textiles, Chennai to revive and revitalize the Ramanathapuram District Co-operative Spinning Mill for the year 2012-13 and the balance 50% Rs.691.125 lakhs) will be released in the year 2013-14 out of the funds received under Special Central Assistance to Scheduled Castes Sub Plan 2013-14.

- 8. Necessary additional funds over and above, the provision made in BE 2012-13 will be provided in RE/FMA 2012-13. Pending provision of such funds, the Commissioner, Adi Dravidar Welfare is authorized to draw and disburse the amount sanctioned in para 6. However this item of expenditure will be brought to the notice of the Legislative Assembly by Specific Inclusion in the Supplementary Estimate 2012-13. The Commissioner, Adi Dravidar Welfare is requested to send necessary proposals to Finance (AD&TW)Department for inclusion of the Expenditure in the Supplementary Estimate 2012-13 and in RE/FMA 2012-13.
- 9. The sum of Rs.74,86,43,504/- (Rupees Seventy four crore, eighty six lakhs fourty three thousand, five hundred and four only) sanctioned and released to TAHDCO as at para 7 above shall not be paid in cash but shall be credited to the following head of account by means of an account payee cheque in favour of the Personal Deposits Account of TAHDCO Limited:-
 - "K Deposits and Advances (b) Deposits not bearing interest 8443 00 Civil Deposits 800 Other Deposits BY Deposits of Tamilnadu Adi Dravidar Housing Development Corporation Limited (TAHDCO), (DPC 8443 00 800 BY 0004) ('out go') (DPC 8443 00 800 BY 000G) (Receipt)
- 10. The Commissioner of Adi Dravidar Welfare, Chennai -5, is authorized to draw the amount sanctioned in para 4 above. He is also authorized to issue the Account Payee Cheque in favour of "Personal Deposit Account" of the Tamilnadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO), with Account Number and disburse the same to Tamil Nadu Adi Dravidar Housing and Development Corporation Limited, Chennai. The Commissioner, Adi Dravidar and Tribal Welfare directed to effect necessary adjustments of the expenditure on the staff cost of the Monitoring and Evaluation cell by making necessary transfer entries with the accounts of the Accountant General.
- 11. The Managing Director, Tamilnadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO), and the Commissioner of Adi Dravidar Welfare are directed to maintain separate accounts for Special Central Assistance funds operated and disbursed by them for the various components separately for every financial year for implementing various Welfare Schemes. The relevant registers for the various

disbursements of assistance should be maintained with the complete details of beneficiaries. The Managing Director, Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO) / The Commissioner of Adi Dravidar Welfare should ensure that the funds are utilized for the real purpose and to the actual beneficiaries fully without any shortfall or complaints. If any failure is noticed in this regard severe action will be taken against the Officers, who are responsible for such lapses. The Managing Director, Tamilnadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO) and the Commissioner of Adi Dravidar Welfare are requested to send the details of expenditure under the Special Central Assistance schemes for each and every month on or before 10th of the succeeding month to the Government.
