#### ORDER:

- 62 Government Industrial Training Institutes are functioning in the State. Most of the buildings of these Government Industrial Training Institutes are more than 40 years old and are in a demolished condition and they are in a state of not fit for use. Hence, during the discussion on demand of Labour and Employment Department in the budget session 2011 2012, the Hon'ble Minister for Labour had announced that the Government Industrial Training Institutes will be renovated on a phased manner and 15 Government Industrial Training Institutes will be renovated for the year 2011 12 at an estimate of Rs.15 crores.
- 2. Hence, in the letter read above, the Director of Employment and Training had proposed to renovate the Government Industrial Training Institute at Pudukkottai as detailed in the Annexures I and II. He had requested the Government for permission to renovate the buildings of Government Industrial Training Institute, Pudukkottai as per the estimate as detailed in Annexure I and to procure the equipments and tools as in Annexure II following the procurement procedures in force and to sanction funds as below:

Civil and Electrical Works -Rs.51.43 lakhs

- 3. The Government have carefully examined the proposal of Director of Employment and Training and decides to accept it. Accordingly, the Director of Employment and Training is permitted to renovate the Government Industrial Training Institute, Pudukkottai as in the Annexures I and II, and sanction is accorded for a sum of Rs.1,00,00,000/- (Rupees One Crore only) towards Civil and Electrical Works and for procurement of Tools and Equipments following the procedures in force.
- 4. The expenditure sanctioned in para 3 above is debitable under the following Head of Account:-

However this expenditure

shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate 2012 - 2013. The Director of Employment and Training is also requested to send necessary draft explanatory notes to Government in Finance (BG I) Department for inclusion of the expenditure in the Supplementary Estimates.
