ORDER:-

In the G.O first read above, Government have created a separate Directorate to look-after the Welfare of Most Backward Classes and Denotified Communities, with a Director in the cadre of an Indian Administrative Service as the Head of the Department.

2. In the G.O second read above, orders have been issued to change the designation of the Director of Backward Classes and District Backward Classes Welfare Officers as Director of Backward Classes and Minorities Welfare, and District Backward Classes and Minorities Welfare Officers respectively, in order to provide adequate coverage and due importance in the implementation of Welfare Schemes and to implement the Prime Minister's New 15 Point Programme for the Welfare of Minorities.

3. In the letter, third read above, the President of the Tamil Nadu Muslim Munetra Kazhgam, has requested the Government that a separate Department for the Welfare of Minorities may be created as has been done by the neighbouring states so that the Welfare of the Minority people in this State will also be protected.

4. The Government of Tamil Nadu is determined to promote and safeguard the rights granted to the minorities under the Constitution of India. taking into account the economic and educational backwardness of the minorities, as pointed out in the report of the Justice Rajindar Sachar Committee constituted by the Union Government of India and also, to give an effective steps to the Prime Minister's New 15 Point Programme for the Welfare

of Minorities, the Government have decided to establish a separate Directorate exclusively for the Welfare of Minorities.

5. The Government, accordingly, order the creation of a separate Department viz Directorate of Minorities Welfare to look after the Welfare of the Minority Communities in the State. The Government also sanction a post of a Director in the cadre of an Indian Administrative Service as the Head of the Office with immediate effect. The Director so appointed shall be conferred with the status of a Head of the Department of the Tamil Nadu State Government with adequate administrative and financial powers to operate the expenditure as and when provided.

6. The Government also sanction the following staff for a period of ONE YEAR from the date of employment or till the need there for ceases, which ever is earlier, subject to the condition that the post of a Driver shall be outsourced through TEXCO

7. Sanction of additional clerical staff to execute the functions of the Department will be issued separately. Till such time the Director of Minorities Welfare shall draw personnel from the Director of Backward Classes and Minorities Welfare to attend to the work relating to the establishment of the Department.

8. The staff sanctioned in para 6 above shall be eligible to draw pay and other Allowances as admissible under the orders in force.

9. The Director of Minorities Welfare will carry out all the items of works intended for the Welfare of Minority Communities and for the successful implementation of Prime Minister's New 15 Point Programme for the Welfare of Minorities. Apart from the above, the Director of Minorities Welfare will take all sorts of steps to extend and enlarge the various facilities and programmes which can uplift the status of Minorities in this State. Further, the Director will take effective steps to improve the economic conditions and to eradicate the educational backwardness of the minorities and to give specific and special attention on the programmes and recommendations pointed out in the report of Justice Rajindar Sachar Committees and to promote and safeguard the rights granted to the minorities under the Constitution of India.

10. The expenditure sanctioned in para 8 above shall be debited to a new Sub – Head of Account to be opened under Demand No. 9 as detailed below.
