## ORDER:

After the publication of the names of members of the State Hajj Committee, the first meeting of the Committee shall be convened within 45 days at which the State Hajj Committee, shall elect a Chairperson from amongst its Members as per section 21 (1) of the Hajj Committee Act, 2002 (Central Act 35 of 2002).

- 5. The rules regarding Hajj Committee Act, 2002 (Central Act 35 of 2002) shall be issued separately.
- 6. The Notification appended to this order will be published in the Tamil Nadu Government Gazette Extra-ordinary dated the 20.11.2006.
