## **ORDER:**

The Government, in its Budget Announcement and Policy Note for 2007-08 have announced Job Oriented Training / Skilled Development Training Schemes at an estimated cost of Rs.2.50 Crores for the Minorities through TAMCO benefiting 5000 beneficiaries. These Skill Oriented Training to Minorities shall be given in the field of Information Technology / Dress Making and other field which will enhance the potential of Minority peoples and enable them to get better employment opportunity.

2. The Managing Director, Tamil Nadu Minorities Economic Development Corporation has informed that the Skill Oriented Training to Minorities will be given in the fields of I.T/Dress Making and in other fields which will enhance and enable the minority peoples to get better employment opportunity. The Training will boost more number of poor meritorious students from Minority communities to secure employment in State / Central Services / Bank / Public Sector undertakings. The Training Institutions will be identified by a committee under the Chairmanship of the District Collector for imparting skill Training. The selection of candidates will be done by the Selection Committee constituted by the Managing Director, Tamil Nadu Minorities Economic Development Corporation, Chennai – 2. Since the Chennai City is the center for the higher educational activities, the courses like Heavy Vehicle Driving / Training for Service Commission/ Defence and Police Service/Information Technology/Fashion & Garment Constructions/Nursing etc will be imparted after identifying the Institutions/Nodal agencies to the Minority people. The above Training Programme will be conducted both in Central/State Government Institutions and where Government Institutions are not available such courses

will be conducted through reputed Institutions. The training programme may also be conducted to the Minority peoples where the Institutions having Branches at other District Viz., Madurai, Coimbatore, Thirunelveli, Trichy etc. These Institutions will be selected by the Managing Director, Tamil Nadu Minorities Economic Development Corporation, Chennai –2. The Tamil Nadu Minorities Economic Development Corporation will utilize the infrastructure at the district Level, available with the Women Development Corporation.

- 3. The Managing Director, TAMCO has further stated that in order to impart the training Programme, a District Committee will identify the Training Institutes at the District, which will be headed by the, District Collector as Chairman, the project Officer Mahalir Thittam as member, the District Backward Classes and Minorities Welfare officer as member convener of the District Committee. The selection of Beneficiaries in the District will be done by the following committee:
  - District Backward Classes & Minorities Welfare, Officer – Member – Convener
  - 2. Project Officer Mahalir Thittam Member
  - 3. Head of the Department of the Training Institution Member.

The Tamil Nadu Minorities Economic Development Corporation will monitor and implement this skilled Training Programme at Chennai and as well as in the Districts. The Managing Director Tamil Nadu Minorities Economic Development Corporation has assured that this training for recruitment through competitive exams will help some of the Minority students to compete in the UPSC/TNPSC Exams etc. The Managing Director , Tamil Nadu Minorities Economic Development Corporation, thus has requested the Government to sanction and release a sum of Rs. 2.50 Crores for this skilled Training Programme to Minority Communities during 2007 – 2008

- 4. The Government, after careful examination, accept the proposal of the Managing Director, TAMCO and sanction a sum of Rs. 2.50 Crores (Rupees Two Crores and fifty lakhs only) for imparting Skilled Oriented Training to Minorities in the field of Information Technology / Garment design / Knitting etc.
- 5. The expenditure sanctioned in para 4 above shall be debited to a new sub-head of account under Demand No 9 as detailed below:

- 6. The item of expenditure constitutes a New Service for which approval of the Legislature will be obtained in due course. Pending approval of the Legislature the expenditure shall be initially met by drawal of an advance from the contingency fund, orders regarding which will be issued by Government in finance (BG-I) Department. The Commissioner of Minorities Welfare is requested to apply in the prescribed format to the Finance (BG-I) Department for sanction of an advance from the contingency fund along with a copy of the Government Order.
- 7. The Commissioner of Minorities Welfare is the estimating, reconciling and controlling Authority for the above new Sub-head of Account. The pay and Account Officer / Treasury Officer's are requested to open the above new Sub-head of Account in main Accounts.
- 8. The Commissioner of Minorities Welfare is authorised to draw and disburse the amount sanctioned in para 4 above to the Managing Director Tamil Nadu Minorities Economic Development Corporation.
