ORDER:

In the Government order read above, among other economy measures orders were issued to the effect that there will be a total ban on creation of new posts with guidelines on creation of new posts in exceptional cases. However it is found that proposals for creation of new posts are often sent by Government departments in a routine way.

2. The Government has reviewed the status of creation of new posts in Government departments. In view of severe financial constraints, the Government has decided that there shall be a complete ban on creation of new posts in all departments. The Government has also decided that wherever posts are required for operational purposes, such posts shall be filled up by redeployment. In view of this, wherever the Government departments find the need to create any new post, the proposal should necessarily be accompanied by redeployment proposals, very clearly identifying the existing post proposed to be redeployed. The other guidelines on creation of posts continued in the Government order read above shall continue to be in force.
