ORDER:

In the Government order third read above, Government has suspended the payment of Festival Advance to Pensioners for a period of one year.

2. The Government has decided to allow drawal of Festival Advance to the pensioners from the financial year 2002-2003. Accordingly Government direct that the payment of Festival advance to the pensioners is restored and Festival Advance shall be sanctioned to the Tamil Nadu Government Pensioners (both Civil and Teacher Pensioners) from the financial year 2002-2003.
