Interim Arrears -- Payment of Interim Arrear due to revision of Pension / Family Pension pending implementation of the recommendations of the Official Committee – Orders – Issued.

#### **ORDER:**

In the Government order first read above, orders were issued constituting an Official Committee to examine and make necessary recommendations for the implementation of the revision of scales of pay and allowances of State Government Employees, Teachers including employees of Local Bodies based on the decisions of the Central Government on the recommendations of the Sixth Central Pay Commission. The Committee was also requested to make necessary recommendations regarding revision of Pension / Family Pension, Retirement Benefits etc. and submit its report to Government within three months. Subsequently in the Government Order second read above, the tenure of the Committee has been extended for a further period of three months beyond 19—11—2008.

- 2) Considering further time required for submission of final report, the Official Committee has recommended to grant three months Pension + Dearness Pension + Dearness Allowance as on 1-1-2009 as Interim Arrear amount to all Pensioners including Family pensioners. The Government has carefully examined the recommendation of the Official Committee and decided to accept it. Accordingly, Government direct that an Interim Arrear amount of three months Pension + Dearness Pension + Dearness Allowance as on 1-1-2009 be sanctioned to all pensioners including family pensioners as on 1-1-2009, pending issue of Government Orders based on the recommendations of the Official Committee to be made on revision of Pension / Family Pension.
- 3) In respect of Pensioners and Family Pensioners for whom the expenditure is met from State Funds, the expenditure shall be debited to '27 Pensions' under the relevant Minor, sub-head under the Major head under "2071.Pensions and other Retirement Benefits". In respect of Pensioners and Family Pensioners of Local Bodies for whom expenditure is met from the funds maintained by the Director of Local Fund Audit, the expenditure shall be met from the respective funds.

- 4) Necessary funds will be provided in RE / FMA 2008-09. Pending provision of funds in RE / FMA 2008—09 and inclusion of the expenditure in Final Supplementary Estimate 2008—09, the Treasury Officers / Sub-Treasury Officers / Pension Pay Officer / Public Sector Banks concerned shall claim and disburse the Interim Arrear amount to the Pensioners / Family Pensioners immediately before the end of January, 2009. The Principal Accountant General (A & E) is requested to include this expenditure while sending proposals for RE / FMA for 2008—09.
- 5) The Interim Arrear amount sanctioned in para—2 above shall be adjusted against the Pension / Family pension arrears to be paid later on the basis of the Government Orders based on the recommendations to be made by the Official Committee.
