Pension – Contributory Pension Scheme – Maintenance of accounts – Contribution from the employees of Local Bodies – Remittance under separate Head of Account – Orders – Issued.

READ the following:-

ORDER:

In the Government Order fourth read above, the Government has entrusted the work of assigning Index Numbers and maintaining the Contributory Pension Fund accounts under Contributory Pension Scheme in respect of the following employees to Government Data Centre:-

- (i) Teachers of Panchayat Union Schools,
- (ii) Teachers of Aided Schools / Institutions,
- (iii) Non-Teaching Staff of Panchayat Union Schools.
- (iv) Municipal Corporation and Municipal Employees,
- (v) Non-Provincialised Employees of Town Panchayats,
- (Vi) Non-Provincialised Employees of Panchayat Unions.
- 2. In the above said Government Order among others, it has been ordered therein that the amount recovered as contribution from the Employees of Local Bodies shall be credited in to the Government Account ordered in the Government Order second read above as amended in the reference third read above directly by the Local bodies every month.

3. Now Government has decided that the contribution from the employees of Local Bodies shall be debited under a separate Head of Account. Government accordingly in partial modification of the orders issued in para 5 of the Government Order fourth read above, direct that the amount recovered from the employees of Local Bodies towards Contributory Pension Scheme (CPS) together with Government contribution shall be credited to the following new Head of Account:-

 - (v) Non-Provincialised Employees of Panchayat Unions.
- 5. The contribution from the employees of Aided Educational Institutions shall continue to be remitted under the head of account prescribed in the Government letter third read above.
