#### ORDER:

Based on the recommendations of the Official Committee, 1998, the scales of pay of Section Officers / Private Secretaries in Tamil Nadu Secretariat Service was revised as Rs.6500—11100 with effect from 1—1—96 as against the pre-revised scale of pay of Rs.2000—3500 on par with their counterparts in Central Secretariat Service. In the reference second read above, the Government of India has now made further revision of scale of pay for the post of Section Officer in Central Secretariat Service to Rs.8000—13500 notionally with effect from 01—01—1996 with monetary benefit from 03—10—2003 subject to the condition that the employees concerned should have completed four years in the grade. The Tamil Nadu Secretariat Association has therefore requested to revise the scale of pay of the posts of Section Officers / Private Secretaries in Tamil Nadu Secretariat Service from Rs.6500—11100 to Rs.8000—13500 on par with their counterparts in Central Secretariat.

2) After careful consideration, the Government have decided to extend the benefit of further pay scale revision granted to the Section Officers in Central Secretariat Service to the Section Officers / Private Secretaries in Tamil Nadu Secretariat Service. Accordingly, Government direct that the scale of pay for the posts of Section Officers / Private Secretaries in Tamil Nadu Secretariat Service be revised from Rs.6500—11100 to Rs.8000—13500 with effect from the date of issue of this order.

- 3) The fixation of pay in the revised scale shall be made as per the provisions under FR 23.
- 4) Consequently, the Selection Grade / Special Grade scales of pay shall be applicable as per Schedule—II of the Government Order first read above.
- 5) The above order is also applicable to the similar posts in Governor's Secretariat.
- 6) In respect of similar posts in Tamil Nadu Public Service Commission and High Court, orders will be issued separately by Personnel & Administrative Reforms and Home Departments respectively.
