## **ORDER:-**

During the Collectors' Conference held on December 2012, the Hon'ble Chief Minister has announced that "2 Fly overs one each at Kalavasal junction and Goripalayam Junction in Madurai will be sanctioned".

2. The Chief Engineer (Construction and Maintenance) Highways Department in his letter read above has reported that the preparation of Detailed Project Report for the work of 2 fly overs one each at Kalavasal Junction and Goripalayam Junction in Madurai has been taken up under Revolving Fund. Sanction of funds for the preparation of Detailed Project Report is required separately to meet out the expenditure to be incurred for the work. The fund in Budget Estimate 2013-2014 is Rs.100.00 lakhs only and the expenditure incurred so far is Rs.50.00 lakhs. Hence, Revolving Fund is not sufficient to accommodate the ongoing Detailed Project Report works, since this head is utilized by all wings of Highways Department.

3. The Chief Engineer (Construction and Maintenance) Highways Department has therefore requested the Government to accord administrative sanction of Rs.65.00 lakhs for the preparation of Detailed Project Report work which involves preparation of detailed design, drawings, GAD and estimate, preparation of land plan schedule, land acquisition estimate, collection of traffic data, traffic survey etc., for the work of 2 fly overs one each at Kalavasal Junction and Goripalayam Junction in Madurai.

4. The Government after careful examination, accept the proposal of the Chief Engineer (Construction and Maintenance), Highways Department and accord administrative sanction to a sum of Rs. 65.00 lakhs (Rupees sixty five lakhs only) for the preparation of Detailed Project Report for the construction of 2 fly overs one each at Kalavasal Junction and Goripalayam Junction in Madurai.

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account:-

“5054 – Capital Outlay on Roads and Bridges – 80 – General – 004 – Research and Development –I-Non Plan – AA – Investigation / Estimation of Project work under Roads and Bridges – 16 – Major Works”.(DPC 5054-80-004-AA-1609)

6. The expenditure sanctioned in para 4 above is an item of “New Service”. The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by sanction of an advance from the Contingency Fund, orders regarding which will be issued by the Government in Finance (BG.I) Department. The Chief Engineer (Construction and Maintenance), Highways Department, Chennai is requested to send necessary proposals to Government in Finance (BG.I) Department, in the prescribed format along with a copy of this order for sanction of an advance required for the current year from Contingency Fund. He is also requested to send a draft explanatory notes for including the above expenditure in the Supplementary Estimate 2013-14 to Finance (BG.I) Department without fail.

7. This order issues with the concurrence of Finance Department vide its U.O No.278/JS(Dr.PU)/PW-I/13, dated 18-09-2013 and ASL No. 1228 (One thousand two hundred and twenty eight).
