ORDER:

In the letter read above, the Director of Medical and Rural Health Services (ESIS) has sent the proposal for implementation of ESI Scheme to Vazhapadi and Karipatti area in Salem District by setting up of a "two doctor type" ESI Dispensary, at Vazhapadi, as per the survey report of the Regional Director, ESIC, Chennai and feasibility report of the Regional Administrative Medical Officer, Salem.

- 2. The Government after careful examination, accept the proposal of the Director of Medical and Rural Health Services (ESIS) and sanction the implementation of ESI Scheme to Vazhapadi and Karipatti area in Salem District by setting up of a "two doctor type" ESI Dispensary at Vazhapadi.
- 3. Sanction is also accorded for the creation of the following 14 posts and for the recurring and non-recurring expenditure involved in this proposal as follows:-

6. The expenditure sanctioned in paragaraph 3 above shall constitute an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature the expenditure will initially be met from an advance drawn from the contingency fund regarding which orders will be issued separately in

Finance (BG-I) department. The Director of Medical and Rural Health Services (ESIS) is directed to apply for sanction of contingency fund in the prescribed proforma along with the copy of this order to Government in Finance (BG-I) department and to send necessary proposal for Supplementary Estimates for inclusion of this expenditure in the Supplementary Estimates for 2012-2013 to Government without fail.

- 7. The expenditure will be initially incurred by the State Government out of the Budgetary provision for 2012-2013 and fully reimbursed from the Employees State Insurance Corporation for the first three year period, from the date of implementation of Employees State Insurance Scheme in the above area and thereafter, the expenditure shall be shared between the Employees State Insurance Corporation and the State Government in the agreed ratio of 7:1.
- 8. The formal Notification under Section 1(3) of the Employees State Insurance Act, 1948, fixing the date from which the medical facilities shall be extended to the Insured Persons and their families in the above area will be issued by the Central Government.
- 9. The Director of Medical and Rural Health Services(ESIS) shall suggest immediately a suitable date for the extension of the Employees State Insurance Scheme to the above area after making all the medical arrangements in the said dispensary in consultation with the Regional Director, Employees State Insurance Corporation, Chennai.
- 10. This order issues with the concurrence of the Finance Department vide its U.O.No. 37703/CMPC, Dated 28.6.2012 and Finance (L&E) U.O.No.210/JS/PM, dated 28.6.2012, and Additional Sanction Ledger No.527 (Five Hundred and Twenty Seven).
