From the Director of Medical & Rural Health Services (ESI), Ref. No. 12544/ESI/P1/2010-1, dated 14.5.2010 and 24.12.2010.

ORDER:

The Hon'ble Minister for Labour while moving this Department's Demand for the year 2010-2011, on the floor of Assembly on 30.4.2010 has made an announcement that Unani Units will be opened at ESI Hospital, Ayanavaram, Chennai.

- 2. In the letters read above, the Director of Medical and Rural Health Services (ESIS), has sent the proposal regarding opening of Unani Units at ESI Hospital, Ayanavaram, Chennai.
- 3. The Government after careful examination, accept the proposal of Director of Medical and Rural Health Services (ESIS) and sanction the opening of Unani Units in Employees State Insurance Hospitals at Ayanavaram, Chennai.
- 4. Sanction is also accorded for creation of the following posts to the Unani Units in Employees State Insurance Hospitals at Ayanavaram, Chennai and for utilizing the other posts by redeployment with the existing staff of the concerned ESI Hospitals:-
 - (i) Unani Doctor (Assistant Surgeon) 1 post (Rs.15,600-39100+GP Rs.5400)
 - (ii) Unani Pharmacists 1 post (Rs.5200-20200+GP Rs.2800)
- 5. The Director of Medical & Rural Health Services (ESI) is directed to post the above staff in the Unani Units in Employees State Insurance

Hospitals at Ayanavaram, Chennai not before one month from the date of actual implementation of the scheme in the said Employees State Insurance Hospital.

- 6. The Director of Medical and Rural Health Services (ESI) is requested to review the working of this scheme after six months of its introduction and to furnish a report to Government and also to follow the instructions for opening of an "Unani Unit in ESI Hospitals issued by the ESIC, New Delhi in the establishment of Unani Units in the Employees State Insurance Hospitals at Ayanavaram, Chennai.
- 7. The Government also accord sanction for incurring the following recurring and non-recurring expenditure:

- 9. The Director of Medical and Rural Health Services (ESI) is the Estimating, Reconciling and Controlling authority of the above new head of account. The Pay and Accounts Officer / Treasury Officer concerned are directed to open the above new head of account in their accounts.
- 10. Necessary additional funds will be provided in RE-FMA 2011-2012. Pending provision of such funds in RE/FMA 2011-2012 the Director of Medical and Rural Health Services (ESI) is authorized to draw and disburse the amount sanctioned in paragraph '7' above. The Director of Medical and Rural Health Services (ESI) should included the additional expenditure while sending the proposal to Government for inclusion in RE/FMA 2011-2012 without fail. However, this expenditure shall be brought to the notice of Legislature by specific inclusion in the Supplementary Estimates 2011-2012. The Director of Medical and Rural Health Services (ESI) is also requested to send necessary draft explanatory notes to Government in Finance (BG-I) Department for inclusion of the Supplementary Estimates 2011-2012.
- 11. The expenditure will be initially incurred by the State Government out of the Budgetary provision/Additional provisions now sanctioned for 2011-2012 and fully reimbursed from the Employees State Insurance Corporation for the first five year period, from the date of implementation of Employees State Insurance Scheme in the above area and thereafter, the

expenditure shall be shared between the Employees State Insurance Corporation and the State Government in the agreed ratio of 7:1.

12. This order issues with the concurrence of Finance Department vide its U.O.65073/CMPC/2011, dated 9.12.2011 with Additional Sanction Ledger No.975 (Nine Hundred and Seventy Five).
