- 4. The posts sanctioned in paragraph 3 above are eligible to draw the pay and allowances in force, as applicable to the related scales of pay.
- 5. The Director of Medical and Rural Health Services (ESIS) is directed to post the above staff in the 10 ESI Dispensaries of four Regions in Tamil Nadu not before one month from the date of actual implementation of the scheme in the said ESI Dispensaries in their respective Regions.

- 6. The Director of Medical and Rural Health Services (ESIS) is requested to review the working of this scheme after six months of its introduction and to furnish a report to Government and also instructions for opening of Siddha Units in 10 ESI Dispensaries issued by the ESI Corporation, New Delhi will be followed in the proposal for establishment of Siddha Units in 10 ESI Dispensaries in four Regions in Tamil Nadu as detailed in paragraph 1 above.
- 7. The Government also accord sanction for incurring the following recurring and non-recurring expenditure:-

- 9. Necessary additional funds will be provided in RE/FMA 2011-12. Pending provision of such funds in RE/FMA 2011-12 the Director of Medical and Rural Health Services (ESIS) is authorized to draw and disburse the amount sanctioned in paragraph 7 above. The Director of Medical and Rural Health Services (ESIS) should include the additional expenditure while sending the proposal to Government for inclusion in RE/FMA 2011-12 without fail. However, this expenditure shall be brought to the notice of Legislative by specific inclusion in the Supplementary Estimates 2011-2012. The Director of Medical and Rural Health Services (ESIS) is also requested to send necessary draft explanatory notes to Government in Finance (BG-I) Department for inclusion of the Supplementary Estimates 2011-2012.
- 10. The expenditure will be initially incurred by the State Government out of the Budgetary provision/ Additional Provisions now sanctioned for 2011 2012 and fully reimbursed from the Employees State Insurance Corporation for the first five year period, from the date of implementation of Employees State Insurance Scheme in the above area and thereafter, the

expenditure shall be shared between the Employees State Insurance Corporation and the State Government in the agreed ratio of 7:1.
