#### ORDER:

In the Government Order first read above, orders were issued, among other things, for the sanction of one post of Examiner, one post of Reader, and two posts of Copyists to the Designated Court No.1 Poonamallee.

- 2. In Government Order second read above, the Government issued orders to transfer the above surplus temporary posts from Designated Court No.1 Poonamallee to the Labour Court, Chennai for a period from 15/11/1995 to 09/04/1997.
- 3. In the Government Order 3<sup>rd</sup> read above the Government issued orders for the continuance of the said posts for a period of one year from 01/07/2006 to 30/06/2007. In the Government Order 4<sup>th</sup> read above the Government allowed to continue the said posts for a period of one year from 01/07/2007 to 30/06/2008. In the Government Order 5<sup>th</sup> read above the said posts were further continued from 01/07/2008 to 30/06/2009. In the Government order 6<sup>th</sup> read above the said posts were further continued from 1/7/2009 to 30/6/2010. In the G.O. 7<sup>th</sup> read above the Government have issued orders for the continuance of the said posts for a period of one year from 1/7/2010 to 30/6/2011. In the G.O.8<sup>th</sup> read above the Government have issued orders for the continuance of the said posts for a period of one year from 1/7/2011 to 30/6/2012.

- 4. The Registrar General, High Court, Chennai, in his letter 9<sup>th</sup> read above has requested to sanction further continuance of the Principal Labour Court and the temporary additional posts sanctioned to Principal Labour Court which have been continuing till date beyond the period of sanction.
- 5. The Government after careful examination, accept the proposal of the Registrar General, High Court, Chennai for the continuance of the following posts to the Principal Labour Court, Chennai for a further period of one year from 01/07/2012 to 30/06/2013 or till the necessity ceases, whichever is earlier, subject to the condition that, no post is kept vacant for more than six months:-
