### **ORDER :**

The Commissioner of Labour in his letter read above has sent proposals to constitute a committee for fixation of Minimum rates of wages for employment in Knitting Industry. The Government accept the recommendation of the Commissioner of Labour and have decided to constitute a committee under section 5(1) (a) of the Minimum wages Act, 1948 (Central Act XI of 1948), to hold enquiries and advise them in the matter of fixation of the minimum rates of wages for the employment in Knitting Industry.

2. The Chairman of the Committee is requested to take necessary action to submit the report of the Committee to Government within six months from the date of issue of this order.

3. The Committee shall be treated as a First Class Committee for the purpose of Travelling Allowance and Daily Allowance. The Chairman of the Committee is authorised to countersign the Travelling Allowance bills of the non-official members of the Committee and the Assistant Commissioner of Labour in the Office of the Deputy Commissioner of Labour, Coimbatore is authorised to draw and disburse the amount to the non-official members, as per G.O.(MS) No.551, Finance (Allowance) Department, dated 3.11.2004 and G.O.(MS) No.28, Finance (Allowance) Department, dated 29.1.2008.

4. The expenditure on account of the Travelling Allowance for non-official members shall be debited to the following head of account:

**“2230 - Labour and Employment - 01 Labour - 001  
Direction and Administration-I Non-Plan AA Headquarters  
Staff - Commissioner of Labour -04.Travel Expenses - 01-  
Tour Traveling Allowance”

**5. The term of office of the non-official members of the Committee shall be six months from the date of issue of this order.**
