ORDER:

In recent years, skill development is given main focus at the National level and the State Government is also keen in producing multi skilled workforce through Industrial Training Institutes to meet the growing Industrial demands. In Industrial Training Institute curriculum, Information Technology has been added as one of the subjects and National Council for Vocational Training (NCVT) has made it mandatory that all Industrial Training Institute students must be trained in computers as computer literacy becomes the basic requirement to make them employable in the present day industries.

2. In Government Industrial Training Institutes, training is imparted in Information Technology related trades of Computer Operator and Programming Assistant (COPA), Desk Top Publishing operator (DTPO), Information Technology and Electronic System Maintenance (ITESM), Computer Hardware and Information Technology (IT-CoE) trades. The students studying in these trades do computer programming, design, desk top publishing works, hardware study & repair and service of computers etc,. Supplying of Laptop will be of much helpful to these students to pursue their programme related study even at home and will also create an interesting learning atmosphere among these students in learning computer skills. Hence during the Review Meeting of Labour and employment Department on 16.03.2012, the Hon'ble Chief Minister has approved the proposal for free supply of Laptop Computers to the students studying in Information technology (IT) related trades of Government Industrial Training Institutes.

3. Accordingly, in the letter read above the Director of Employment and Training has proposed for extending the scheme of free distribution of Laptop computers to the trainees of Information Technology related trades of all Government Industrial Training Institutes as below:

Hence, the Director of Employment and Training has requested the Government to sanction a sum of Rs.347.60/- Lakhs (Rupees Three Hundred and Forty Seven Lakhs and Sixty Thousand only) for the year 2012-13 for the free distribution of Laptop computers to 3476 beneficiaries and proposed to follow the existing procurement procedure followed in supply of free laptops to the school and college students.

4. The Government carefully examined the above proposal and accept it and extend the scheme of free distribution of Laptop computers to the trainees of Information Technology related trades in Government Industrial Training Institutes as at para – 3 above and sanction is accorded for a sum of Rs.347.60 lakhs (Rupees Three Crores Forty Seven lakhs and

Sixty Thousand only) towards implementation of the scheme. The scheme will be covered under existing scheme of free distribution of Laptop computers to the students of schools and colleges, for the purpose of procurement and the Director of Employment and Training is directed to entrust the ELCOT for procurement of the Laptop computers by placing additional indent as per requirement.

5. The expenditure sanctioned in para 4 above shall be debited to the following new sub - heads of accounts opened under Demand No.32.03: -

BX Deposits of Electronics Corporation of Tamil Nadu Ltd, (ELCOT) DPC 8443-00-800-BX 000E (Receipts)"

8. The expenditure sanctioned in para 4 above shall constitute an item of "New Service". The approval of legislature will be obtained in due course, pending approval of the Legislature, the expenditure will initially be met from an advance drawn from the Contingency Fund orders regarding which will be issued separately in Finance (BG1) Department. The Director of Employment and Training is directed to apply for sanctioning of Contingency Fund in the prescribed form in duplicate to Finance (BG.1) Department, along with the copy of this order. The Director of Employment and Training is also directed to send necessary draft explanatory notes to Government in Finance Department for inclusion of this expenditure in the supplementary estimates 2012-2013 to obtain the approval of the Legislature at the appropriate time.
