### **ORDER:-**

In the Government Order Second read above, sanction was accorded to Thiru.P.S.Raman, former Additional Advocate General-I of Tamil Nadu and then Accountant General of Tamil Nadu for appearance in, High Court of Madras in W.P.No's 28741/08, 28749/08,28782/08, 28783/08 and 28805/08 filed by the Tamil Nadu Spinning Mills Association, Dindigul, against the notification for fixing the minimum rates of wages payable to the apprentices employed in Textile Mills under Minimum Wages Act, 1948 and the Government Pleader/Special Government Pleader, High Court of Madras was requested to give full

assistance to Thiru P.S.Raman, former Additional Advocate General-I of Tamil Nadu, High Court of Madras to conduct the batch cases.

2. In the letter third read above, Thiru P.S.Raman, former Additional Advocate General-I of Tamil Nadu has sent the fee bill for a sum of Rs.4,00,000/- for his 8 appearance in the above said batch cases by charging Rs.50,000/- per day and requested the Government to sanction the special fees for the appearances made by him before the Hon'ble High Court of Madras. He has also requested the Government to sanction a sum of Rs.66,666/- to Tmt.Lita Srinivasan, then Government Advocate and Rs.66,667/- to Tmt. Puspha Menon, then Government Advocate, High Court of Madras for their assistance made in the above said cases.

3. In the letter 5<sup>th</sup> read above, the Public (Law Officers) Department have issued instruction with regard to settlement of special fees to Advocate General / Additional Advocate Generals, for their appearance prior to 1.11.2010, by allowing at a rate of 3 ½ (three and half times) increase of the normal fees prescribed as in GO(MS) No.1259, Public (LO) Department, dated.31.10.2006. It has also instructed to settle the fees of Law officers at the earliest following the instructions issued thereon.

4. Based on the instruction issued by the Public (LO) Department as stated at para 3 above, the Government accords sanction for a sum of Rs.3,36,000/- (Rupees Three lakhs thirty six thousand only) to Thiru.P.S.Raman, former Additional Advocate General-I, of Tamil Nadu and then Accountant General of Tamil Nadu for his eight appearances (8 x Rs.42,000/-) in the batch cases in W.P. No's 28741/08, 28749/08, 28782/08, 28783/08 and 28805/08 and also accords sanction for a sum of Rs.56,000/- (Rupees Fifty six thousand only) each to Tmt.Lita Srinivasan and to Tmt.Puspha Menon, then Government Advocates, High Court of Madras for their assistance made to the former Additional Advocate General-I of Tamil Nadu in the above mentioned batch cases.
