ORDER:

In the letter first read above, it has been stated the Government of India introduced Textile workers Rehabilitation Fund Scheme (TWRFS) on 15.9.1996 for providing relief to the displaced workers of Non – SSI Private Textile Mills closed on or after 6.6.1985, provided such mills are declared closed under section 25(0) of Industrial Disputes Act, 1947 subject to fulfillment of the eligibility guidelines prescribed under Textile Worker Rehabilitation Fund Scheme.

- 2) In G.O. second read above, orders were issued declaring the following 8 Mills deemed to have been closed under section 25 (0) of Industrial Disputes Act, 1947.
 - 1. Muthaliyandan Spinning Mill Private Limited, Sholingar
 - 2. Yogalakshmi Spinning Mills Private Limited, Sholingar

 - 4. Mahalakshmi Textiles Mills Limited, Madurai

- 6) The Commissioner of Labour, Chennai is requested to obtain the workers list on roll at the time of closure of the Mill either from the concerned Management or from Union concerned, if any and verify the same with reference to the pay rolls available with Assistant Provident Fund Commissioner of the concerned district and then forward to the Joint Commissioner of Textile, Government of India, Mumbai to get the relief sanctioned to the displaced workers under Textile Workers Rehabilitation Fund Scheme (TWRFS) immediately.
