# <u>ORDER</u>

In the Government Order first read above, a committee was constituted for revision of minimum rates of wages for employment in Hosiery Manufactory under clause (a) of sub-section (1) of section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948) and it was published as Labour and Employment department Notification No.II(2)/LE/666/2012 on page 536 of part II Section 2 of the <u>Tamil Nadu Government</u> Gazette dated the 10<sup>th</sup> October 2012.

- 2) The Commissioner of Labour in his letters 2<sup>nd</sup> read above has requested to extend the period of the said committee for six months from 12.1.2013 and to nominate Thiru.G.R.Senthilvel vice Thiru.K.Ramesh Kumar as Employers' Representatives.
- 3) The Government after careful examination, accept the proposal of Commissioner of Labour to extend the term of office of the period of submission of the report of the said committee for a further period of six months from 12<sup>th</sup> January 2013 and also to appoint Thiru.G.R.Senthilvel in the place of Thiru.K.Ramesh Kumar as Employers' Representatives.
- 4) The appended Notification, will be published in the <u>Tamil Nadu Government Gazette</u> both in English and Tamil.
