### ORDER:-

In the letter first read above, the Principal, K.S.R. College of Engineering, Tiruchengode, Namakkal District, has stated that their College is approved by All India Council for Technical Education, New Delhi and affiliated to Anna University of Technology, Coimbatore for the Course M.E., (Industrial Safety Engineering) with the Students intake strength of 18 and he has requested to approve the said course under Factories Act for recruiting their College Students as Safety Officers by the Industries.

- 2. In the letter second read above, the Director of Industrial Safety and Health has stated that the Principal, K.S.R. College of Engineering, Tiruchengode, Namakkal District, has submitted an application seeking approval of the Post Graduate Course M.E., (Industrial Safety Engineering) for the appointment of Safety Officers in factories, as prescribed under rule 3(1)(b) of the Tamil Nadu Safety Officers (Duties, Qualifications and Conditions of Service) Rules, 2005 and also stated that they have obtained approval from All India Council for Technical Education and Department of Technical Education, Chennai and having required faculty and other infrastructure and laboratory facilities and he has further stated that the copies of the curriculum and syllabus of the Anna University as sent by the Institution has been verified and found in order.
- 3. The Director of Industrial Safety and Health has also stated that the Commissioner of Technical Education, Chennai-25 and the Registrar, Anna University, Chennai-25 have been approached for remarks and the Director, Centre

for Academic Courses Anna University, Chennai-25 has given its recommendation whereas the Commissioner of Technical Education, Chennai-25 has constituted a Committee and the Committee had its sitting on 20.2.2013 recommended the course conducted by KSR College of Engineering, Tiruchengode, Namakkal District, and considered the course for appointment of Safety Officers in Factories. Hence, he has recommended that the request of the Institution for the approval of M.E., (Industrial Safety Engineering) under rule 3(1) (b) of Tamil Nadu Safety Officers (Duties, Qualification and Conditions of Service) Rules, 2005 may be considered.

4. After careful examination, the Government have decided to accept the recommendation of the Director of Industrial Safety and Health. Accordingly under Clause (b) of sub-rule (1) of rule 3 of the Tamil Nadu Safety Officers (Duties, Qualifications and Conditions of Service) Rules, 2005, the Governor of Tamil Nadu hereby approve the Post Graduate Course M.E.,(Industrial Safety Engineering) conducted by K.S.R. College of Engineering, Tiruchengode, Namakkal District, for the appointment of Safety Officers in Factories.
