From the Director of Medical and Rural Health Services (ESI) letter No.3021/ESI/P1/2012, dated 17.12.2012.

ORDER :

The Hon'ble Minister for Labour has made an announcement in the floor of Assembly on 8.5.2013 that the Achampadu areas will be attached with the existing ESI Dispensary.

2. In the letter read above, the Director of Medical and Rural Health Services (ESIS), has sent the proposal for implementation of ESI Scheme in the Achampadu areas, Radhapuram Taluk, Tirunelveli District by attachment with the existing ESI Dispensary, Nanguneri.

3. The Government after careful examination, accept the proposal of the Director of Medical and Rural Health Services (ESIS) and sanction the implementation of ESI Scheme to the Achampadu areas, Radhapuram Taluk, Tirunelveli District by attaching 155 Insured persons with the existing ESI Dispensary at Nanguneri. Sanction is also accorded for incurring a recurring expenditure of Rs.85,250/- (Rupees Eighty five thousand two hundred and fifty only) towards provision of medicine to 155 employees and their family members.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

“2210 Medical and Public Health – 01 Urban Health Services – Allopathy – 102 Employees State Insurance Schemes – I Non-plan – AG – Expenditure on ESI Scheme - Both insured persons and their families – 66 medicine”

5. Necessary additional funds will be provided in RE/FMA 2013-2014. Pending provision of such funds in RE/FMA 2013-2014, the Director of Medical and Rural Health Services (ESI) is authorized to draw and disburse the amount sanctioned in paragraph '3' above. The Director of Medical and Rural Health Services (ESI) should include the additional expenditure while sending the proposal to Government for inclusion in RE/FMA 2013-2014 without fail.

6. The expenditure will be initially incurred by the State Government out of the Budgetary provision/Additional provisions now sanctioned for 2013-2014 and fully reimbursed from the Employees State Insurance Corporation for the first three year period, from the date of implementation of Employees State Insurance Scheme in the above area and thereafter, the expenditure shall be shared between the Employees State Insurance Corporation and the State Government in the agreed ratio of 7:1.

7. The formal Notification under Section 1(3) of the Employees' State Insurance Act, 1948, fixing the date from which the medical facilities shall be extended to the Insured Persons and their families in the above area will be issued by the Central Government.

8. The Director of Medical and Rural Health Services (ESI) shall suggest immediately a suitable date for the extension of the Employees' State Insurance Scheme to the above area after making all the medical arrangements in the said dispensary in consultation with the Regional Director, Employees' State Insurance Corporation, Chennai.

9. This order issues with the concurrence of Finance Department vide its U.O.36025/Fin(L&E)/2013, dated 12.7.2013 with Additional Sanction Ledger No.723 (Seven hundred and twenty three).
