The following Notification will be published in the <u>Tamil Nadu</u> Government Gazette:-

#### NOTIFICATION.

WHEREAS, the Governor of Tamil Nadu is satisfied that public interest requires that "All the Co-operative Institutions registered under the Tamil Nadu Co-operative Societies Act, 1983 engaged in procurement, storage and distribution of essential commodities" should be declared to be a public utility service for the purposes of the Industrial Disputes Act 1947 (Central Act XIV of 1947);

NOW, THEREFORE, in exercise of the powers conferred by sub-clause (vi) of clause (n) of section 2 of the Industrial Disputes Act, 1947 (Central Act XIV of 1947), the Governor of Tamil Nadu hereby declares all the Co-operative Institutions registered under the Tamil Nadu Co-operative Societies Act, 1983 engaged in procurement, storage and distribution of essential commodities, to be public utility services for the

purposes of the said Central Act XIV of 1947 for a period of six months with effect on and from the date of publication of this Notification in the <u>Tamil Nadu Government Gazette</u>.
