ORDER:

In the G.O. first read above the Government have accorded sanction to the enhancement of rent from Rs.28,050/- to Rs.30,600/- p.m. w.e.f.1.10.2001 to the O/o the Assistant Commissioner of Labour (Conciliation-II), the Labour Officer, I, II and III Circles, Chennai which are accommodated in the IIIrd Floor of the building of the Tami Nadu Khadi Village Industries Board, Kuralagam, Chennai-108.

- 2. The Commissioner of Labour, Chennai in his letter second read above has reported that the management of Tamil Nadu Khadi and Village Industries Board has enhanced the rent at the rate of Rs.15.50 per Sq.ft. and refixed the rent for the portion occupied by the Labour Department Offices in the above building at Rs.39,525/- Per mensum w.e.f.1.03.2007. The Commissioner of Labour has therefore, requested the Government to sanction of enhanced rent to the said offices at Rs.39,525/- Per mensum w.e.f.1.03.2007.
- 3 The Government have examined the proposal carefully and they hereby accord sanction for enhancement of the rent from Rs.30,600/- to 39,525/- (Rupees Thirty nine thousand five hundred and twenty five only) with effect from 1.3.2007 to the offices of the Assistant Commissioner of Labour (Conciliation-II) Chennai, Labour Officer-1, II and III Circles, Chennai, functioning in the III Floor of the

Kuralagam Building, Chennai 108. The Government hereby sanction an additional amount of Rs. 4,99,800/- (Rupees Four lakh ninety nine thousand and eight hundred only) towards arrears of enhanced rent.

- 4. The expenditure sanctioned in para 2 above shall be debited to "2230. Labour and Employment 01. Labour 101. Industrial Relations-I Non Plan-AA. Conciliation Machinery 06 Rent, Rates and Taxes-01Rent. (D.P.Code No.2230-01 101 AA 0610)
- 5. The Labour Officer-I, Chennai is authorised to draw and disburse the enhanced rate of rent sanctioned in para 2 above and the arrears of enhanced rent duly adjusting the rent already paid to the Tamil Nadu Khadiand Village Industries Board under proper acquittance and vouchers.
- 6. Necessary additional funds will be provided in RE/FMA2011-2012 pending provision of such fund in RE/FMA2011-2012. The Commissioner of Labour should include the additional expenditure while sending the proposal to Government for including in RE/FMA 2011-2012 without fail.
