In exercise of the powers conferred by section 27 of the Minimum Wages Act, 1948 (Central Act XI of 1948), the Governor of Tamil Nadu hereby makes the following amendment to Part I of the Schedule to the said Act, the notice of the intention of the Government of Tamil Nadu in respect thereof having already been published, as required by the said section of the said Act.

AMENDMENT

In the said Act, in the Schedule, in Part I, after the expression “91. Employment in Distillery Industry”, the expression “92. Employment in Hand Embroidery and Jari” shall be added.


