

## <u>ABSTRACT</u>

Writ Petition No.37794/2003 filed by the Association of Matriculation and Higher Secondary Schools Management, Tirunelveli, Writ Petition No.5159/04 filed by the A.R.R.Matriculation Higher Secondary School, Kumbakonam and other Writ Petitions /Writ Miscellaneous Petitions filed against the orders of the Government in G.O.(2D)No.34, Labour and Employment Department, dated 5.5.2003 regarding fixation of Minimum Wages for the Employment in Coaching Academics- Appearance of Thiru S.Gomathinayagam, Additional Advocate General-II – Orders – issued.

### ORDER:

In the Government Order first read above, orders were issued fixing minimum rates of wages for the employment in Coaching Academics such as Tutorial Colleges, Technical Institutions, Primary or Nursery Schools, English Medium Schools run on Commercial lines without Government grant, other than those run by Government and local bodies, as the case may be.

- 2. Aggrieved by the above orders of the Government, the Association of Matriculation and Higher Secondary Schools Management, Tirunelveli, and A.R.R.Matriculation Higher Secondary School, Kumbakonam filed Writ Petitions (W.P.No.37794/2003, W.P.No.5159/2004 respectively) in the High Court, Madras. Certain other Managements of Schools, Educational Trust and Associations have filed Writ Petition/ Writ Miscellaneous Petition in the High Court, Madras challenging the orders issued by the Government, in the order first read above.
- 3. The Government in its order second read above, have accorded sanction of appearance of Thiru.S.Veeraraghavan, Additional Advocate General-III, High Court, Chennai, in Writ Petition No.37794/2003 and W.P.No.5159/2004, other similar Writ Petitions/ Writ Miscellaneous Petitions filed by the managements of various Schools, Association etc, and the Government Pleader/Additional Government Pleader, High Court, Chennai was requested to give their full assistance to Thiru.S.Veeraraghavan

the Additional Advocate- General-III, High Court, Chennai till the disposal of the above cases.

- 4. Now, the Commissioner of Labour, in his letter third read above, has requested the Government, to kindly issue fresh orders sanctioning the appearance of Thiru.S.Gomathinayagam, Additional Advocate General II, High Court of Madras to conduct the cases on behalf of the Government relating to W.P.No 37794/2003, W.P.No 5159/2004 and other Writ Petition/ Writ Miscellaneous Petition filed by certain managements of schools, Educational Trust and Association against the orders issued by the Government in its order first read above.
- 5. The Government, after careful examination, sanction the appearance of Thiru. S. Gomathinayagam, Additional Advocate General-II, High Court, Chennai, in Writ Petition No.37794/2003 and W.P.No.5159/2004, filed by the Association of Matriculation and the Management of Higher Secondary School, Tirunelveli and A.R.R.Matriculation Higher Secondary School, Kumbakonam and other similar Writ Petition/ Writ Miscellaneous Petition filed by the managements of various Schools / Associations etc, against the orders issued by the Government in the G.O.(2D) No.34, Labour & Employment Department, dated.5.5.2003 and the Government Pleader/Additional Government Pleader, High Court, Chennai is requested to give full assistance to Thiru. S. Gomathinayagam, the Additional Advocate-General-II, High Court, Chennai, till the disposal of the above cases.
