ORDER:

In the Government Order first read above, preliminary notification has been issued to revise the minimum rates of wages for the employment in Forestry. The Commissioner of Labour in his letter 2nd read above has suggested certain amendments to the said Government Order and the notification issued therewith.

2) The Government, after careful examination, have decided to accept the proposal of the Commissioner of Labour. Accordingly the following amendments to the said G.O.(2D) No.44, Labour and Employment (J1) Department, dated 28.9.2012 are issued:-

AMENDMENTS.

1) In the above said G.O, in the first page,-

(1) Under the heading “Read:-“

The references 1 and 2, shall be renumbered as 2 and 3 respectively, and before the reference as so renumbered the following shall be added namely:-

“1. G.O.(2D) No.56, Labour and Employment (J1) Department, dated 27.12.2002.”

- 2) Under heading "ORDER:" for the first paragraph the following paragraph shall be substituted, namely :-

"In the Government Order first read above, the minimum rates of wages for the employment in Forestry were revised under the provisions of the Minimum Wages Act, 1948 (Central Act XI of 1948). The Government now rescind the Government Order second read above, wherein it has been proposed to revise the said minimum rates of wages, considering the request of Principal Chief Conservator of Forests. The Government have now proposed to further revise the minimum rates of wages for the Employment in Forestry".

- 3) Accordingly, the appended Notification will be published in the Tamil Nadu Government Gazette.

- 4) The Tamil Development and information Department is requested to supply the Tamil Translation to the works Manager, Government Central Press, Chennai-600 079, directly.

- 5) The Works Manager, Government Central Press, Chennai-79 is requested to send five copies of Gazette Notification to the Government for reference and record purpose.
