ORDER:

The term of the office of the non-official members in the Minimum Wages (State) Advisory Board last reconstituted in the G.O. read above had already expired. The Government have therefore decided to reconstitute the Minimum Wages (State) Advisory Board for the purpose of co-ordinating the work of the Committee and sub-committee appointed under section 5 of the Minimum Wages Act for advising the Government generally in the matter of fixing and revising minimum rates of wages. The Commissioner of Labour has sent necessary proposals to Government for reconstituting the Board suggesting the names of employees and employers representatives and independent members to be appointed to the Board. After considering the proposals of the Commissioner of Labour the Government direct that the Minimum Wages (State) Advisory Board be reconstituted as indicated in the Appendix to this order.

- 2. The Works Manager, Government Central Press, Chennai-79 is requested to publish the appended Notification in English and Tamil. The Tamil Development, Religious Endowments and Information Department, Chennai-9 is requested to supply the Tamil translation of the notification to the Works Manager, Government Central Press, Chennai-79.
- 3. The term of office of the non-official members shall be two years commencing from the date of their nomination. But the non-official members, shall continue to hold office until their successors are nominated.
- 4. The Board will be treated as a first class Committee for the purpose of travelling allowance/Daily Allowance. The Deputy Commissioner of Labour (Minimum Wages). (Secretary of the Board) will

countersign the Travelling Allowance/Daily Allowance and the Administrative Officer (Minimum Wages) / Office of the Commissioner of Labour is authorized to draw and disburse the amount to the Non-Officials Members.

5. The expenditure on account of the travelling allowance and daily allowance shall be debited to -
