## NOTIFICATION.

Whereas, the Governor of Tamil Nadu is satisfied that public interest requires that the Industrial Units whose entire production is exported and the Industrial Units established in the Special Economic Zones should be declared to be public utility services for the purposes of the Industrial Disputes Act, 1947 (Central Act XIV of 1947).

NOW, THEREFORE, in exercise of the powers conferred by sub-clause (vi) of clause (n) of section 2 of the said Act, the Governor of Tamil Nadu hereby declares the Industrial Units whose entire production is exported and the Industrial Units established in the Special Economic Zones to be public utility services for the purposes of the said Act, for a period of six months with effect on and from the date of publication of this Notification in the <u>Tamil Nadu</u> Government Gazette.
