ORDER:

In the Government Order read above, orders were issued for the publication of Preliminary Notification in respect of extension of provisions of the Employees' State Insurance Act, 1948 (Central Act XXXIV of 1948) to Private Medical Institutions under sub-section (5) of section 1 of the said Act.
