#### **ORDER:-**

In the Government Order first read above, a Preliminary Notification was issued for amending the rule 4 of the Tamil Nadu Factories Rules, 1950.

- 2. The above said Notification was published at pages 16 and 17 of Part III Section 1 (a) of the <u>Tamil Nadu Government Gazette</u>, dated 24.03.2010 inviting objections, if any, from persons who are likely to be affected within 45 days from the date of publication of the said Notification.
- 3. Accordingly, certain objections / suggestions were received from certain Managements / Associations. The objections / suggestions were considered in detail by the Government. After careful consideration, the Government have decided to revise the rates of licence fees proposed in the Preliminary Notification.
- 4. Accordingly, the Preliminary Notification for amending rule 4 of the Tamil Nadu Factories Rules, 1950 notified in the Government Order read above is hereby confirmed with revised rates of licence fees as prescribed in this notification.
- 5. The appended Notification will be published in the <u>Tamil Nadu</u> Government Gazette both in English and Tamil.

- 6. The Tamil Development, Religious Endowment and Information (Translation) Department, Chennai.9 is requested to furnish the Tamil Translation of the Notification to the Works Manager, Government Central Press, Chennai.600 079.

#### **APPENDIX.**

### **NOTIFICATION.**

In exercise of the powers conferred by section 112 of the Factories Act, 1948 (Central Act LXIII of 1948), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Factories Rules,1950, the Draft of the same have been previously published as required under Section 115 of the said Act.

#### **AMENDMENTS.**

In the said Rules, -

(1) in rule 4, for "THE SCHEDULE", the following SCHEDULE shall be substituted, namely:-

- (2) in rule 56-B, for sub-rule (2), the following sub-rule shall be substituted, namely:-
  - "(2) The fee payable for the examination and testing of pressure plant or vessel or water sealed gas holder shall be as follows:-
    - (i) ₹400/-(Rupees four hundred only) per plant or vessel irrespective of its size or capacity, for the external examination;
    - (ii) ₹1000/- (Rupees one thousand only) per plant or vessel upto 4 kgf/sq.cm(g) for the Hydrostatic test;
    - (iii) ₹2000/- (Rupees two thousand only) per plant or vessel above 4 kgf/sq.cm.(g) for the Hydrostatic test;
    - (iv) ₹1000/- (Rupees one thousand only) per plant or vessel irrespective of the size or capacity, for the internal examination; and
    - (v) ₹4000/- (Rupees four thousand only) per plant or vessel irrespective of the size or capacity, for the non-destructive ultrasonic thickness gauging test.";
    - in rule 67-A, in clause (iv), in sub-clause (a), for the expression "Rs.50/- (Rupees fifty only)", the expression "₹ 100/- (Rupees one hundred only)" shall be substituted;
    - (4) in rule 86-A, in sub-rule (b), for the expression "₹50/- (Rupees fifty only)", the expression "Rs.100/- (Rupees one hundred only)" shall be substituted; and
    - in rule 95, in sub-rule(1-A), in clause (a), for the expression "₹50/- (Rupees fifty only)", the expression "₹100/- (Rupees one hundred only)" shall be substituted.
